# **ABSTRACT**

I am pleased to provide Glemsford Parish Council with the analysis of the responses to the 2018 Village survey.

# **INTRODUCTION**

Following on from the last village survey in 2011, another village questionnaire was issued to all residents during the last few months of 2018.

This document provides the results of all returned questionnaires for the 2018 survey.

In all there were **806** completed or partially completed questionnaires returned for consolidation into an Excel Worksheet. Of these, **14** were returned blank and are therefore not included in the results so the analysis was based on **792** questionnaires. This document offers no personal opinion regarding the results to each question – nor in relation to the free text responses, simply a graphical representation of each questions particular option scores. Every written response received is also included for consideration in text as these responses are impossible to accurately, or fairly represent with a simple table or graph.

When considering the scoring against each question I would ask you to bear in mind that not everyone completed every question with the issued questionnaires, neither did everyone provide written comments in the free text boxes. Additionally, some questions invited the respondent to tick or select more than one option. A number of single questionnaires were completed by two people in that household which will also slightly skew the number totals against some of the questions where additional boxes were ticked.

Where free text answers were supplied I have, where possible, corrected blatant spelling errors but I refrained from changing punctuation or grammatical 'errors' to avoid changing the tense of the individual's response.

Whilst great care was taken in the inputting of the raw data into the Excel spreadsheet I would advise that an overall error rate of 0.2% (zero point two percent) would be an acceptable error rate due to human error.

All returned papers have been kept for auditing purposes (if required). These will be given to Cllr Steve Plumb once the final inputting has been completed.

Although some personal information was supplied on or within certain returned questionnaires, I have omitted these from all associated results to protect individual's data etc.

There were some question errors within the issued questionnaires as follows:

Section 'I' – Question I6 was inadvertently numbered I4 – This has been rectified within this document.

Section 'L' – within the Age Groups of question L2 the options towards the end of the range went from Age 45 - 65 followed by Age 60 plus. I have simply included the answers exactly as received for this question.



A total of 410 responses to this question is much lower than the 792 papers recorded. However, a number of respondents mentioned the fact that they were actually retired hence the low number.




How much do you agree or disagree with the following statements? Please circle a number.

A 2 There is adequate and suitable employment within or within easy reach of Glemsford



# A 3 Glemsford will only ever be a provider of minor employment opportunities



#### The following free text responses were received in relation to section A:

#### 111 responses were received in total:

- 1. Social amenities (pubs etc) have suffered and declined as a direct result of, or in line with, a parallel decline in local employment.
- 2. I would welcome a range of small industrial units within walking distance of the village.
- 3. We've recently moved to the village and are very unfamiliar with it.
- 4. Industries that employ local people not just business that brings money to the village.
- 5. It's a village!
- 6. A2 We believe there is plenty of employment available locally if people wish to seek it. A4 Depends on what business would be and whether Glemsford people would get a say on how beneficial the business would be.
- 7. If the employee is reliant on public transport finding work is difficult. Even more so in the case of young families.
- 8. As long as traffic does not impact on roads e.g. wedding venue = big mistake!
- 9. Glemsford is currently only a good place to live (re employment) if you drive. Minimum employment opportunities within the village that I can see. 3600 live here I doubt there are jobs here for 5% of the population.
- 10. Lack of childcare provision after school, therefore if one is reliant on public transport it is virtually impossible to find employment as a single parent.
- 11. I am now retired. Moved to Glemsford from out of the area just seven months ago. Not really had the time to formulate opinions for most of this questionnaire.
- 12. I have just retired from working in BSE and if I had not had my own car I should have found it impossible to hold down a full time 9 5 job as the transport system is abysmal.
- 13. Infrastructure not suitable for business development.
- 14. Glemsford is a village and therefore should not be expected to be a provider of business development or employment. There is employment within easy reach of Glemsford as long as you have your own transport.
- 15. My job is quite specialist, therefore I choose to commute further afield.
- 16. Employment would be easier if there was a better bus service
- 17. A business park would be inappropriate to the village.



- 18. I don't believe there is an adequate bus service for people to be able to use public transport to and from work and this must be a problem for people without their own car.
- 19. It is a village. I moved here for a quiet life, not expecting loads of jobs.
- 20. 4 garages closed. Houses. Silk Mill closed houses. Downs engineering closed houses. Bakers closed houses.
- 21. Employment outside of Glemsford especially for people who work shifts if they rely on public transport.
- 22. But only when it doesn't impact on the village, its environs and the wild life, i.e. New Street Farm development
- 23. Glemsford is a village with great amenities. It is within easy reach of Sudbury, Cambridge, Bury St Edmunds, Ipswich and London via Sudbury. Plenty of opportunities to work.
- 24. For people who do not drive, Glemsford might as well be the moon. People think they can just park their cars anywhere they want.
- 25. I believe it is very important to increase what Glemsford offers our older children and younger adults.
- 26. Back in the 1980's there were three large employers in the village, plus one on the lower road. This still remains although a different company.
- 27. It is difficult to see how sufficient employment could be created in the village for any significant number of residents.
- 28. There are plenty of industrial areas vacant in Sudbury and Haverhill, with the massive Delphi site soon to join them. Ruining an area of the village to provide employment opportunities will not be needed.
- 29. Ruining the landscape to create jobs isn't the answer. People are capable of travelling to work where necessary.
- 30. There is also a Residential Care Home in Glemsford which appears to have been omitted from the list.
- 31. Retired
- 32. As a small business owner, we have not been able to find a small/medium business unit for sale within 7 miles of Glemsford. We have been searching for 3 years. This makes it impossible to expand our business.
- 33. A2 It's good if you drive, public transport makes it difficult.
- 34. We are within half an hour of Bury St Edmunds, Sudbury, Halstead and Newmarket. Plenty of opportunity.



- 35. We feel the village should remain a village. Keep fields and green areas.
- 36. The lovely people of Glemsford like to moan, local small business will not survive/thrive without support from the local community.
- 37. Historically Glemsford has provided lots of employment opportunities, silk mills, horse hair factory, glass factory, Downs etc.
- 38. In this day and age people expect to learn to drive and there are plenty of opportunities in Bury, Sudbury and many can work from home also.
- 39. More local employment means less cars on the road which has multiple benefits.
- 40. We are new to the area, just getting to know the village really.
- 41. Light cottage industries
- 42. The heart of the village doesn't need more business related traffic, let alone residential.
- 43. Living outside the village (Fernhill) a lot of these issues do not really affect us.
- 44. Small business provide over 2/3 of this nation's employment and half of this nations wealth. This is the sort of business development and agriculture and conversation that showed hold priority.
- 45. This is a rural area and should remain so.
- 46. No figures showing how many village people work in Glemsford or want to.
- 47. I would not like to see large factories on the outskirts of Glemsford. Small units in a group i.e. Clockhouse Farm would be much more pleasing to the eye.
- 48. Access to the village is limited so further traffic will cause chaos. As many houses sit close to the road heavy vehicles will impose on the residents.
- 49. Glemsford needs to extend employment opportunity by including and ensuring small scale business development in the overall plan. Otherwise as (A3) opportunity will be limited.
- 50. Need more frequent public transport!!!
- 51. A4 Husband agrees strongly but on a very small scale wife disagrees!
- 52. Sorry, do not have any idea of employment opportunities in Glemsford being retired, no opinion.
- 53. Retired!
- 54. There was more employment here in the past now some factory units left at farm site. Silk factory and glass factories gone.



- 55. N/A Retired.
- 56. Both residents retired. We worked in Bury St Edmunds and Clare when employed.
- 57. QA4 is too ambiguous do you mean greenbelt land? Are you referring to the ratio of land given to business versus residential development?
- 58. I would like to see more small businesses in keeping with the village coffee shop, tea rooms etc would be good for both residents, passing trade, walkers etc. Promoting both community spirit and pride, and better facilities for visitors Also public toilets would be an advantage.
- 59. Any small scale development should be considered very carefully to ensure that it meets the village's requirements and is sympathetic to the environment also that access is considered carefully and is adequate.
- 60. An area of quality small units providing various services and products could be successful.
- 61. Inadequate infrastructure roads, public transport to support industry.
- 62. Existing farm or brown field only. Not at the expense of green space.
- 63. In a village of our size I find it hard to believe that there are not talented makers and growers. Why do we not have a farmers market or general market? We have adequate venues and space for these to happen.
- 64. Am retired. But for young people would be good to have work locally.
- 65. I would like Glemsford to stay small enough to be a village!! I like it when new builds are built in gaps that were once old run-down buildings, I do not like the feeling of farm land close to the village being built on.
- 66. There is room for more small scale employment (shops, cafes etc) see the bicycle shop etc whilst still preserving the character of the village.
- 67. There already is land (or space) available, eg at Clockhouse Farm.
- 68. Any small scale business development could increase more large vehicle usage.
- 69. May be increase in working from home, bigger part of employment landscape in time. Is there a demand for small scale business development? Should not be done speculatively.
- 70. Retired, do not know current business employment
- 71. Depends on the business! Some will be appropriate to the environment, some will not!
- 72. It is ok to provide more employment as long as the infrastructure can cope.
- 73. Glemsford does need basic employment (unskilled) due to the lack of transport out of the village this would enable young families to earn a little extra.



- 74. Perhaps another site similar to the units at Clock House Farm, with room for some parking for employees and visitors.
- 75. I don't agree that land would need to be made available as business development as I feel there is enough opportunity in the village already and the village couldn't cope with further loss of countryside and the increased traffic this would bring.
- 76. The small scale business development should be discreet and have adequate access eg roads.
- 77. There is no point in extra housing if the employment opportunities are not improved.
- 78. Glemsford did have good employment once upon a time, Downs, mirror factory. People now have to go outside the village as sadly they seem to want more houses.
- 79. I have lived in the village for 33 years. The number of cars has increased dramatically. If there were more local jobs perhaps more people would walk more.
- 80. My employment was always away from the village. Now in my 80's I'm barely mobile except with use of taxis.
- 81. if Glemsford is to keeps its character then large industrial work is not acceptable. Small enterprises such as craft workshops as at Clockhouse Farm could be ideal
- 82. Need to consider why so many businesses have failed to survive over the last 5 years. What rationale would support additional land being made available for small scale business development?
- 83. Glemsford could benefit from supporting knowledge based companies.
- 84. Work from home
- 85. A4 is a no brainer. It is pointless continuing to build homes without providing employment.
- 86. Glemsford used to be a working village but has now become more residential
- 87. Units already exist for small scale business that are not always full.
- 88. I cannot see how the village could accommodate more businesses to create employment.

  More business development would destroy village life and create more traffic problems. We do not need or want this.
- 89. A4 Must be ecologically friendly business with light road usage. Must be knowledge based service industries/businesses if located within 4 miles of village boundaries.
- 90. We only moved to Glemsford at the start of September so haven't a very strong (or valid) opinion Yet!



- 91. Currently I would see limited scope for business increase without significant impact to housing/amenities which should be prioritised.
- 92. Transport links and road improvement would be essential for small scale business development because of logistics and work force.
- 93. Transport is a big issue in Glemsford for people without their own transport.
- 94. More speed signs needed (asap) to more fast drivers. Need more street lights around the village as dark in some pathways and pavements people can't see.
- 95. Transport for work outside of the village is a huge problem for non-drivers.
- 96. Life has changed. We have lost nearly all business have gone people have to go out of the village for employment and a lot of that has gone as well very sad for young people.
- 97. It is understandable by most that you have to travel in this day and age to be suitably employed. Why develop more green areas for industrial use?
- 98. Glemsford is a village and should have employment opportunities that a village deserves, but not too much that makes it too busy as traffic is an issue.
- 99. Lack of public transport means that jobs outside the village are inaccessible to the young and those without private transport This is a key issue for Glemsford.
- 100. Not enough job for young people to start off and now no buses for young and old.
- 101. Employment would be easier if there were better bus/transport connections to Sudbury / Haverhill
- 102. We have one big employer in the village. We should bring them in more. Help them to help us.
- 103. Glemsford is a village and certainly would lose the atmosphere of more development.
- 104. When at work we were both employed outside the village.
- 105. If the level of business rates in towns is causing shop closures then Glemsford would struggle to support other businesses.
- 106. A3 I appreciate that Avent is a big employer locally, however people hang on to their jobs there so new opportunities are few and far between.
- 107. Existing buildings, not land should be made available with reasonable rates of rent, business rates etc.
- 108. Business opportunities should be entirely environmental in order to bring in usual investment but only small scale starter IT or cottage industries. Incentives should be promoted.



- 109. Most recent building has been accommodation, Downs's site could have retained its use as an employment area with small businesses!! Silk Mill area is ideal for business.
- 110. Development of small businesses is good but not at the cost of upsetting the residence of those that live in the village.
- 111. Any new business ventures need to be carefully monitored i.e. noise and pollution problems please try to retain a village atmosphere not an industrial estate.



# **B1** The current bus service is adequate for the needs of all Glemsford residents



# **B 2** More parking controls are needed in Glemsford



# **B 3** Speeding is a problem that needs attention





# **C1** Glemsford is well served by its GP practice



# C2 Collection of prescriptions is not a problem



# C 3 I am confident that the village is well served if emergency services (not police) are needed



# C 4 Access to other health services e.g. the Dentist, the Health Centre is not a problem



# C5 Those with disabilities are well served in Glemsford



# C 6 I am confident the police will respond quickly to an emergency or criminal activity in Glemsford



#### The following free text responses were received in relation to sections B and C:

#### 226 responses were received in total:

- 1. Health Centre, Dentists etc all available in Sudbury if you can get there!
- 2. Policing is very poor and will be exploited ass the travelling criminal element become aware of the vulnerability.
- 3. Parking near junctions should be rigorously control Highway Code says no parking within 10 metres of junction.
- 4. Any increase to widen Hobbs Lane. Park Lane should be in conjunction with restrictions of size/weight of large vehicles through very narrow Flax Lane See further comments on next page.
- 5. Teenagers have little to do, nowhere to go.
- 6. More parking space is needed in some places, but I am not sure about 'controls'. No yellow lines in Glemsford please.
- 7. Buses appalling weekend service. Sudbury and Haverhill back please!
- 8. B1 Not frequent enough and expensive to use. B3 Main roads out of village are speeding spots, especially Brook St. C1 They do their best to keep up with the increasing demands of the village. C4 Access to them may be difficult if need to get the bus as the bus service does not go to the health centre. Either a long walk from Sudbury bus station, or by taxi service will be needed to get there.
- 9. Too many people don't clean up after their dogs. Some of the paths are overgrown by weeds.
- 10. No buses to get to dentist or health centre. Unable to get bus back from work in Sudbury/Melford. What police!! No car no life.
- 11. The most recent bus changes are appalling. I personally have no problems with seeing a GP or collecting my medications but I know it's not good for everyone. I strongly believe all emergency services would struggle accessing the village. Anti-social behaviour seems to be on the increase.
- 12. I think people need to be educated on parking, I don't feel that parking is an issue just that sometimes inefficient room is left for larger emergency vehicles.
- 13. I drive so none of these affect me, my doctors is in Long Melford, no of above has affected me.
- 14. Inadequate parking throughout village. Poor emergency vehicle access.
- 15. If bus service were more adequate this would make C4 and C5 much better.



- 16. More buses are needed and not only to Sudbury. A 2 hourly service is not enough.
- 17. Parking is so dangerous when coming up from the school to Wongs you can't see if a driver is coming down because of the parking outside Wong's. We suggest that if we have sleeping policeman or humps in the road to slow people down because they drive so fast that somebody will have a terrible accident.
- 18. Drug pedalling. Gypsies using association house as drugs den. Also leaving three scrapped vans on premises.
- 19. Improved over last five years.
- 20. Theft appears to be an issue (cars, tools etc) from people's properties. Seems like a personal security issue that individuals must deal with, however I'm not sure how the police deal with this.
- 21. Need to see police more often.
- 22. I do think roads are too narrow especially main roads into the village. I don't feel the bus service is adequate. I own a home care company and see many improvements that could be made in relation to disability management.
- 23. When the population grows the GP practice will need to be improved. It's about time we had our own dentist practice.
- 24. Schoolfield needs speedbumps to much fast traffic. Schoolfields needs the edge of the green and grass areas tarmacked for extra parking and so emergency vehicles can pass safely.
- 25. Police have had to call when responding to emergency calls as they could not find my property (old address). New road, still un-named, 6 months after residents moved in.
- 26. Public transport is impossible and needs improving.
- 27. A huge problem with speeding in the village as a mother/father who walk children to school there is often speeding at 40/50mph especially along the Tye Green stretch. Parking issues include no zebra crossing and so hard to cross given number of cars parked on road and lack of sight. Many acres / vans also park up on the path meaning pram has to be pushed in the road, with other child walking alongside.
- 28. The football ground is often left with empty bottles, food packaging and left overs!
- 29. C3 Maybe the way people park would cover the issue.
- 30. Several years ago vandalism and anti-social behaviour was a problem in the village, though these issues were addressed with good results. However, cuts in services could aggravate the situation with seditious effects.
- 31. We don't use the bus or any disability services so can't comment. Speeding is a problem along Brook Street out of the village and into the village.



- 32. Far too many cars/vans park on corners and junctions that restrict the view of oncoming traffic and make it hard for ambulances to get through/prams, wheelchairs to safely use a path.
- 33. Parking at the end of Brook Street is a real issue. Cars park opposite the junction that causes real problems when turning in. As you have to be on the wrong side of the road to turn in.
- 34. I think the GP surgery struggles with the current demand although they do a good job. More houses would see even more pressure put on the service, increase waiting times for appointments further strain on the roads in terms of parking.
- 35. Buses could run more efficiently, especially to BSE.
- 36. Have noticed in the last few months, several cars have been speeding through. Glemsford is served by dentist etc as long as you have your own transport (again, if not, lack of buses makes it hard to access services.) Made worse by there being no buses on Saturday now, last bus during the week is about 5.30 pm.
- 37. We need a police patrol to deter crime and only good access if you have a car, difficult for pensioners.
- 38. Littering is a problem
- 39. Many garden thefts.
- 40. I believe the nearest dentist is either Sudbury or Melford. Although I think the surgery is good I believe it needs more than the current doctor numbers it has and could be more sympathetic with regard to flu jab clinics only 2 mornings, which for medical reasons may not be appropriate is not good enough.
- 41. Anti-social behaviour on play equipment in Kings Road green play area.
- 42. It is hard to get in to see GP, but good once there. Kids in village are horrible, can't even use bins when standing next to them. Smashed glass and rubbish where I walk dogs. It has been so bad I had to carry them, not easy as they are heavy.
- 43. Prescriptions delivered to my home.
- 44. When I village was half the size police house and full time Now village massive more crime than ever no police impossible to fix now.
- 45. No Saturday bus service this needs addressing, bus service too infrequent. Need to be able to get a blood test at Glemsford surgery, as I am nearly 90 it is difficult to have to keep travelling to health centre in Sudbury for blood tests!
- 46. Cars parked half on the pavements make it difficult for prams and wheelchairs to use the pavements and bins being left out on the pavement permanently
- 47. B To a certain extent the narrow roads have a calming effect on traffic travelling through the village. C I cannot really comment on Glemsford surgery as I am registered at Melford.



- 48. Police cover is inadequate
- 49. Not familiar with bus service.
- 50. People or households with more than one car should not be allowed to park them outside other people's houses if they can't fit them on their own driveway. It's greedy and leads to problems.
- 51. On road parking is a major problem in some parts of the village. This needs to be addressed before emergency vehicles struggle to get through, more homes or businesses are built or extended. Serious accidents occur, or people get killed while out walking because they cannot be seen from the road. Or because footpaths are not available due to parking or inappropriate for wheelchair users.
- 52. Don't agree with adequate transport as we have no service on Saturdays to Sudbury and only 4 times during the week. People working Saturdays can't get transport to work. And stuck in Glemsford on Saturdays with changes being made in Sudbury cinema, shops etc we won't be able to make use of any of it on Saturdays and other times have to wait couple of hours for bus.
- 53. With no local police station and those in Sudbury, Haverhill not being manned 24/7 how can they respond quickly.
- 54. The bus service is poor, therefore getting to the Sudbury health centre is difficult and to get connecting services. Although the GP practice is good, increasing population puts a strain on their services as the doctors are all part timers.
- 55. C4 transport to Sudbury, Bury would be needed if not a car owner this would be extremely difficult. C6 response times (if they attend) are totally inadequate.
- 56. C4 What dentist
- 57. C4 ok if can drive but difficult if reliant on public transport.
- 58. Car parking is dreadful within the whole of Glemsford, such as parking on footpaths, and parking on corners throughout the village, parking close to exiting points of side roads, might be an idea to change Tower Meadow into a car park getting parking off the roads.
- 59. Due to very poor public transport it is not possible for some to access the Health Centre in Sudbury. Policing is no longer a priority for petty crime. Young people should have things to do.
- 60. Section B. Have lived here for 1 year only and cannot really answer 1 2 3
- 61. If roads are upgraded will mean more house building will be allowed in village.
- 62. Up at the skate park and all the parks are littered with broken glass and bottles etc



- 63. The current situation with the Sudbury bus is a problem. More parking is needed, especially around School field and certain parts of the Kings Road estate. Speeding is also a problem in these areas and also the Horseshoe (Shepherds Lane, Plum St). The health centre is a problem to get to if you don't drive and the taxi fares both ways will cost you £30.00.
- 64. Have only lived here for a couple of months.
- 65. More off road parking required.
- 66. The more homes built means more the doctor's time needed getting to many now. Police what police waste of time if problem need to sort it out yourself. When there was a village copper it was a lot safer.
- 67. We have had no problem with crime, but realise it is present, but am sure other villages have crime there also.
- 68. The Saturday bus service recently discontinued by Beestons needs to be re-instated asap. Also a more frequent bus service needed. The blood testing facility that used to be available at Glemsford surgery should be re-instated as it is a nuisance having to travel to Sudbury or Bury to get this done, especially for people who have to have frequent blood tests.
- 69. B4 If we start altering roads around our village we will lose the character of the village.
- 70. Parking on the zigzag lines outside of the school combined with the speed of cars on that stretch of road is a real concern. In general parking laws do not seem to apply in the village with people parking where they like, regardless of the law/safety of others.
- 71. We need more parking areas as new builds and existing cottages do not have adequate parking on their own property.
- 72. With an aging population a good bus service is essential.
- 73. There needs to be better off-road parking at Schoolfield estate the first road in.
- 74. Bus service is minimal from what I have seen (timetable). Never seen police vehicle in Glemsford (Lived here since 22/6/18).
- 75. Speeding is a problem in Glemsford. The main access roads need widening asap.
- 76. Policing is a joke. We had an intruder in our garden which I disturbed. No police turned up, not interested. Was fireworks night last year and lots of other break-ins!
- 77. Parking is a big problem, the corner between the Chinese and the chip shop is increasingly dangerous as people park all round that corner. It doesn't help when people speed round the corner when you can't see what is coming! The same by the Spar. I know there isn't driveways for everyone but need to park sensibly! The roads could be widened to accommodate this but losing footpaths would be more of an issue. I don't use the Glemsford Doctors practice, unable to comment on their service, but it's good to have one in the village.



- 78. Traffic calming through the village and the reduction of parked cars on road and junctions must be addressed and GP car park.
- 79. As a core village the police station is shut and one in the nearest town, seldom manned. A police station needs to be visible above all else.
- 80. Only called police out once and had a poor response. No knowledge of disabled people or crime in Glemsford as no local news is distributed to where I live.
- 81. We badly need police presence in evenings and weekends if only for a short time until antisocial people learn they will be punished they will soon learn.
- 82. The roads (as already stated) would be difficult to widen as many houses sit on/sit close to the pavement. Many of the pavements in the village are very, very narrow. The bus service now, no longer runs at the weekend. The bus has trouble getting through the village roads. The bus needs to be more of a mini bus size and then perhaps it could be more frequent. The large bus is nearly always empty.
- 83. Speed bumps near Cock pub. Bus service not to run up Skates Hill.
- 84. Live too far out of village to really comment.
- 85. B2 parking along all roads is an issue, particularly for emergency services. No development, domestic or industrial should be passed without adequate parking minimum of 2 cars per household.
- 86. More buses!! (That connect with Sudbury trains and Colchester buses).
- 87. C1 OK at present, more expansion of population would be a problem. C4 Health centre, no direct bus service for those with no transport.
- 88. GP services will need to increase with extra housing.
- 89. The bus service to BSE needs enhancing there are not enough. Ie to go to Bury and stay there for a longer period. As for times for the police or emergency services to respond to call-outs isn't really adequate because the distance they have to come.
- 90. With recent cuts in the police force, it is impossible for them to cover all crimes quickly, allowing more crime to go undetected.
- 91. C5 Availability of transport via hospital car privately organised as in Cavendish. B1 Smaller buses.
- 92. B4 won't happen. There isn't even enough money to repair potholes.
- 93. Unable to answer B1 as do not use this facility.
- 94. We do not use Glemsford surgery. The bus service is now greatly reduced in recent years. No longer a connection via Haverhill to Cambridge.



- 95. Bus service to Sudbury recently stopped on Saturdays weekends should be at least as regular also evening/night services needed, to connect with rail services in Sudbury/Bury.
- 96. It is very minor despite the carping.
- 97. I do not feel we need parking controls but any future development needs to have adequate off road parking.
- 98. 236 Bus service is totally inadequate and fails both teenagers (unable to get to Sudbury etc on Sat) School leavers (can't get to work) and elderly (who can't drive or would use public transport if convenient). 754 Is ok at least BSE can be visited on a Saturday. Beestons clearly only want to run a school bus on 236 and another operator should be encouraged with subsidy from SCC to make up service or compete with them. Or school contract should be on condition they provide a community service.
- 99. C5 Unable to comment as we don't know.
- 100. I cannot remember the last time I saw a police officer on foot in Glemsford. As ever inconsiderate/dangerous parking of cars causes frustration throughout the village. The bus service to and from Glemsford is woeful.
- 101. C5 Have no idea. C7 Luckily no personal experience.
- 102. 1 The GP practice is currently under great pressure. ^ What police? We have no police or community police, they only love fight.
- 103. I work every Wednesday morning at the village hall running a group for the community I have been aware there have been times of anti-social behaviour around here. I have to say I think our council do a great job of keeping control of these areas! You can never stop anti-social behaviour but the village hall is well looked after! You do a really good job, I think this every week. I rarely have to clear up before my group. The village cleaner does a wonderful job, please make sure she gets this feedback.
- 104. We have only lived here for 5 months so have not had much use of local services yet. So some of my responses will be around mid-range.
- 105. Unable to comment on some questions having just moved to Glemsford.
- 106. Parking on grasslands is a problem. Speeding along Park Lane and Kings Road is terrible!! Dangerous as we have young children.
- 107. Health services should grow in proportion to any expansion. Give consideration its upgrade Hobbs Lane etc to a 'B' road with improvements and downgrade B1065.
- 108. C4 Reduced bus service makes access more difficult. Also, without a car, no easy access to WSH.



- 109. The doctor's surgery isn't able to serve the population of Glemsford as well as it would like now before any more patients are taken on. W.S.H. is already trying to keep up with demand without future development in the area.
- 110. B2 More parking for new developments. C7 Speeding.
- 111. We have our own mode of transport so unable to comment on bus facilities. We moved from Lavenham and have remained patients there. No dentist in the village.
- 112. Was a few years back but called police to violent domestic incident and waited over 40 mins for assistance then all 3 police cars arrived at same time.
- 113. All '3's indicate I've no personal experience here so don't feel I have the right to an opinion.....
- 114. Would be better if able to collect prescriptions on a Saturday as I work and cannot always get to the surgery in time during the week.
- 115. We need another GP
- 116. Glemsford's parking is outrageous! Almost single lane right through the village, it's dangerous.
- 117. B2 Current situation bottlenecks etc act as traffic calming. Where else can residents park their vehicles? B4 Hobbs Lane should be widened Skates Hill should not. C4 My expectations are that by living in a rural village environment I accept I need to travel for access to some services. C5 Don't feel qualified to comment.
- 118. GP surgery does its best shows concern for patients. But fails its patients by inadequate admin eg insufficient flu vaccine recently. Thus vulnerable patients were told to go to the supermarkets.
- 119. If the village grows the surgery will not be big enough we also have Hartest now theirs have closed.
- 120. Parking is a big problem for residents in Hunts Hill/Egremont Street for residents without driveways. There are people in the croft, mainly croft house who have 2 caravans and many cars which they choose to park in a road they don't even live in. I am sure residents only parking would be a great help to all of us.
- 121. We have an excellent surgery and doctors let's not brake it by making Glemsford too large.
- 122. B1 A more frequent bus service to Sudbury would possibly persuade more people to leave their cars at home.
- 123. I feel if the bus service ceased then access to the dentist and health centre would become an issue for some residents. Maybe thought would have to be given to providing transport for this.
- 124. Our doctor surgery is the best in area. I have not experienced emergency services or antisocial behaviour we live on outskirts.



- 125. I walk my dogs past the old silk mill every day and strongly feel that it is a very dangerous 'playground' for the children I often see around it, covered in vandalism and graffiti, I wish it would just be demolished so it won't injure anyone or be an attraction to those who frequent it.
- 126. B Double yellows on main roads through the village and parking areas for those in houses without drives/garages. Zebra crossing outside school.
- 127. C1 We need more doctors.
- 128. There are already many issues trying to get an appointment. More people and less doctors will not help support our community.
- 129. There have been many recent garage break ins.
- 130. Do not take the bus but have heard it is not running as much or at good times?
- 131. B There are no adequate parking areas (for instance, the school) Maybe a car park somewhere. C4 Relies on bus service.
- 132. Main village road is virtually a single lane road through parking. Ridiculous!! Nothing but praise for the doctors and surgery.
- 133. Current road network & its upkeep does not allow for safe and effective movement around the village. There are some potential improvements but it's difficult to see how further housing developments will improve the situation.
- 134. Speed control in Cavendish Lane (monitored). Speed control round school entrances.
- 135. The current bus service is woefully inadequate for a village this size. The Beestons service has continued to decline and yet the village has continued to expand!
- 136. We need more buses for people as not everyone can drive, and for people to get to and home from work. As for the doctors, you have to wait for an appointment.
- 137. Cars parked on pavements are an issue, especially for pushchairs and wheelchair users.
- 138. Parking in some areas of the village notably around the Angel/Cock area and the now busy road leading to the spar shop. Several near misses witnessed. The condition of the road surface on all roads leading into Glemsford are very poor.
- 139. Boat robbed. Police did not come. Shut case immediately. Other spate of outside robberies along Stour not responded to.
- 140. The speeding along Bells Lane is extremely excessive especially at night which makes crossing road very dangerous.
- 141. Silk mill, constant vandalism by unsupervised children, high theft from vans and sheds.



- 142. Have no experience of access or support for people with disabilities at the moment. Antisocial behaviour/vandalism depends upon which part of the village you live in eg near the village hall or by the old silk mills.
- 143. As far as I am concerned vandalism has improved in the last five years. I have suffered in the past
- 144. Speeding is an issue along Bells Lane
- 145. B1 Restoration of the Saturday bus service to and from Sudbury
- 146. In relation to C4 access to health services is not a problem for those with cars or can afford taxis but the bus service is inadequate to provide good access to the health centre. B1 Restoration of Saturday bus service to Sudbury and return.
- 147. In 3 years have seen no police on foot and only 1 patrol; car in the village. Not good enough.
- 148. Hourly bus service connecting Sudbury to Haverhill should be reinstated. When I needed and ambulance it took 3 hours to arrive.
- 149. It is time the pot holes from last winter were repaired some in Park Lane had cosmetic attention but the holes nee filling in properly.
- 150. B3 Bells Lane particularly bad. C4 Ok if you have a car. C7 House at Horsehair Factory recently broken in to, car keys stolen and car stolen.
- 151. C3 Needs to define separately emergency services as fire appliance response is stationed geographically closer than ambulance. Paramedic response.
- 152. Fair Green, Bells Lane and Brook Street are clogged up with parked cars. Maybe some area, available for building development could be set aside for community car park area, thus freeing up the roads.
- 153. The church is important
- 154. Improved bus services would enable access to dentists etc. The Health Centre is really only viable by car/taxi currently.
- 155. But GP are stretched to the limit, they can only do what is possible. Building more houses will add bigger problems for the few GPs we have.
- 156. NO comment on C1 and C2 as not registered with the Glemsford practice.
- 157. To support Sudbury Town we need buses every day including Saturday so why have they been withdrawn on Saturdays.
- 158. B4 Widening our roads will drop the character of the village. C5 depends on type of disability there are thousands! Badly worded question!
- 159. Very concerned about slow response to theft crime



- 160. Parked cars on the sides of roads e.g. Egremont Street and Bells Lane, this problem must be dealt with. If widening of the roads is not possible what about a one way system.
- 161. Parking on the junction of Spring Meadow and Brook Street is extremely dangerous and needs to be addressed urgently. The same applies to the top of Brook Street. In both cases you cannot see if the road is clear. There is a blind junction at the top of Bells Lane which needs to be addressed urgently.
- 162. Fair Green needs parking restrictions, the Brook Street / Broadway junction and the junction opposite the old Downs site are now extremely dangerous due to the careless/ignorant parking by local residents.
- 163. There is not enough buses into Sudbury, none on a Saturday which makes it a struggle to get to dentist, opticians etc.
- 164. If building of houses continues at the current rate then naturally additional infrastructure needs to follow i.e. schools, doctors, transport.
- 165. Our village needs safe parking spaces/areas rather than parking controls.
- 166. DR's could use more space especially if more houses are built. Prescription collection could be better e.g. more staff. Local transport to the Health Centre would be good. Pavement use with disability scooters is difficult.
- 167. Bus service is desirable but not necessary as the village has all the requirements. DRs, PO, Library, shops, cashpoints. Wider roads will make traffic too fast. Bus service needs to not use large buses except foe school runs. Smaller buses more frequently.
- 168. As I live outside of the village itself I am unaware of any vandalism or anti-social behaviour.
- 169. Access roads must be widened before any more development, Very important.
- 170. A regular service is badly needed, also bus service on Saturday to Sudbury were cancelled. I think the bus service on Saturday should be available and a more regular service during the week to Sudbury and BSE
- 171. There must be a better way of filing repeat prescriptions in the dispensary, those poor ladies have to hunt for ages to find peoples prescriptions, causing long waits at times.
- 172. C4 Only if a car driver!
- 173. C4 I am not aware of a dentist.
- 174. C7 Controls on fly tipping and prosecutions for such offences needs to be enforced. Land owner of the pitch off Post Office Lane must be forced to develop the land. There are dual standards applied to planning consent and what residents in the conservation area can do!



- 175. Bus services are generally poor, especially since reduction of Saturday buses. I'd like to see Chambers take over Sudbury Haverhill as they are better. Access to Sudbury Health Centre can be limited for those who don't drive so need improved access.
- 176. Street parking narrows the road, but I have no off street parking (along with many other properties). Re vandalism, my car was scratched from bonnet to boot and my neighbours truck had super glue put in the locks. However I would not say it was a huge problem occurring on a weekly basis.
- 177. See previous
- 178. More parking is needed
- 179. B4 subject to pedestrian access/safety. B2 Increase in housing in recent years has affected parking/road congestion/safety when pulling out of house.
- 180. Parking around blind junctions is a big issue on Kings Road, as is speeding.
- 181. There have been a few thefts from cars, sheds and garages. Older kids drop litter by the skateboard park
- 182. Drug abuse continues
- 183. Dentists and health centre in Sudbury have good access for car owners but not so easy for non-drivers. Petty crime seems to flare up from time to time but it seems fine at the moment.
- 184. C4 Access is a problem if residents don't have transport. Buses are infrequent; also serve the school population so could be intimidating or too crowded for some people
- 185. Passenger numbers influence the bus services that run, so are probably adequate.
- 186. The dentist/health centre is fine if you have a car, if you rely on buses it is very difficult
- 187. The bus service has never been good. Dentist and opticians have always been a trip to Sudbury. Seldom see the police in Glemsford although there is evidence of drug abuse in the village.
- 188. Sometimes have to wait 3 days for a prescription.
- 189. What emergency services?
- 190. My husband's van window was smashed in 2 years ago, luckily he didn't leave any tools in. This was in the time travellers were in the area and other vehicles were also broken into. It made us feel very uneasy.
- 191. Speeding along Bells Lane has to be addressed before a fatality occurs. We seem to be the only village in Suffolk never to have any speed traps or anti-speeding activity
- 192. More buses at weekend's services Saturdays extra days of new service go start Tuesdays and Thursdays.



- 193. We don't use the Glemsford GP practice, stayed with old GP.
- 194. The bus service is not good now. I only go now and again after having over the year a fairly good service it gradually declined. Doctors I have not had a problem I try not to go to dentist have to go to Sudbury. That's ok.
- 195. C4 Access to hospital and health centre one very big problem. Like me there's a lot of us don't drive. Taxi is so dear.
- 196. Public transport is deplorable, it is impossible to use for work access and now there is no service even to Sudbury on Saturdays.
- 197. We have to wait weeks for a GP appointment. Prescriptions are never ready or they never have the medication in! More parking is needed near surgery for people who don't drive it is very difficult to get to other services.
- 198. Need a post office that's open.
- 199. Neighbouring villages appear to have more speed control measures in place with a police presence seen regularly (Cavendish as one example).
- 200. Access to services not available in Glemsford i.e. dentist and health centre, are difficult for those residents without their own transport. Pavements would be more accessible for disabled folk if a) there were more dropped kerbs, and b) if hedges adjacent to paths were properly trimmed back and this should be enforced by the parish council. Same applies to all roadsides i.e. Flax lane.
- 201. B4 If the access roads are widened speeding will probably increase particularly in Park Lane / Hobbs Lane. C4 Not a problem if you drive but difficult if relying on public transport.
- 202. B4 improving the access will also lead to more speeding
- 203. B3 Speeding on Lower Road is terrible. C3 Great the First Responders are there and we have used, but we know they have trouble getting volunteers and it shouldn't be down to them.
- 204. C7 I have not personally experienced it but I get out very little. B2 But people have to park somewhere. C1 Drs are good but not enough. C4 It is if you don't drive.
- 205. Trying to get a doctor appointment is a joke that's when they answer the phone.
- 206. There will always be an element of the above C7 but it is not a big problem.
- 207. Doubtful that health services could cope adequately with large population increase.
- 208. I've had two motor bikes stolen. My husband's van lock broken. My sheds have been tried to get broken which they have gone through car port and left door open which is locked from inside.



- 209. Need much better bus service especially for students and young people. More police presence needed.
- 210. Skates Hill parking problem stopping access to village. Traffic using Hobbs Lane. Too small for double decker buses and cars all speeding.
- 211. Parking in green spaces has been a continual problem in our village which has not been addressed over the last 20 years. It is only getting worse.
- 212. Health and fitness go together. More should be done to have outdoor pastimes in the village. Ie Bowling Green, tennis courts.
- 213. Lower Road is a 40MPH speed limit. Living on this road shows that 95% of traffic do not adhere to this, and on occasions it's a very dangerous RD because of this I have asked the police to monitor it to no avail.
- 214. No dentist in the village for those who don't drive.
- 215. Major problems with parking. There needs to be clear no parking areas i.e. double yellow lines on corners and no parking on footpaths. Would also benefit from some kind of traffic calming.
- 216. Health centre and dentist would be a problem for the people without transport. This goes back to the inappropriate bus service.
- 217. Transport. One has to run a car as no transport on Sundays. Also no transport from fairly early in the evenings. Problem if you are a non-driver. Petty crime etc. At the moment it does not seem to be an enormous problem. However would the situation change we would be very concerned.
- 218. GP services can barely cope with current population, further growth will need more GP's/Nurses which is more and more difficult. Police never seen in the village these days, any increase in criminal activity will never be managed under current police levels.
- 219. B2 Cars parked on the main road through village are causing a real problem, but where else can they go unless part of Tye & Fair Greens are altered to allow some parking. C7 I feel petty crime has decreased in last 2 years which is good news.
- 220. Poor parking at junctions e.g. top of Brook St/Bells Lane junction, needs addressing but the village does not need yellow lines etc.
- 221. Parking controls at junctions. Too many parked cars reduces and potential speeding. Access to health services outside the village is tricky if you rely on public transport. Pockets of petty crime but not widespread and a regular occurrence e.g. Friday night/weekend car crimes etc.
- 222. The doctor's surgery needs more capacity and dentistry and other health services centralised around the surgery.
- 223. Glemsford surgery will be harder to get appointments with the closure of Hartest surgery. Widening roads won't happen because of the cost to carry out the work.



- 224. Bus service is inadequate for more houses, Felix should be invited to extend their 1/2 hourly small coaches to include Glemsford so people can get to Sudbury.
- 225. The bus service should be more frequent. On street parking causes too many problems when driving along the main roads in the village. The only sped checks are on Lower Road where the impact of speeding is less, checks should be carried out in the village where the danger caused by speeding is greater. Access to dentist etc is okay for those with a car, probably not for those that rely on public transport. There is little visible police presence in the village and we do hear of petty crime and theft in the village.
- 226. A much improved bus service would cater for a number of problems.















The following free text responses were received in relation to question D 10:

#### 513 responses were received in total:

- Bin locations, far too visible. New housing prohibits rear storage of full grey and blue bins. Summer brings flies and it has been a very bad year for flies and pests. Egremont Street is heritage and conservation area. Bins should not be visible, nor satellite dishes on front of properties.
- 2. Shame police houses were sold off in Suffolk.
- 3. Everywhere you walk there is always dog foul on pavement all around the horseshoe. If you have a dog they should pick up after it.
- 4. Of the unlisted issues, parking is very important, it is only a matter of time before there is a serious injury or fatality as a result of an accident caused by dangerous parking in the village. Parking close to or on, junctions, blind bends and opposite other parked cars. Coupled with speeding this is the most dangerous issue that needs to be addressed.
- 5. Parking in the village, particularly outside doctors.
- 6. Perhaps this is already happening but someone could start up a minibus service with reasonable charges to take older folk to hospitals and other appointments as taxis are so expensive and our bus service is very infrequent.
- 7. Street lighting is perfectly adequate. Light pollution should always be kept in mind. More lighting would also adversely affect the character of the village.
- 8. Anti-social behaviour teenagers hanging out @ village hall lots of litter!! Sometimes loud scary for older single residents.
- 9. Anti-social behaviour.
- 10. Hazard of speeding vehicles, is real problem that needs looking at sooner rather than later!
- 11. Improved bus service.
- 12. Extra facilities for disabled.
- 13. Public transport services and prices need major improvement to BSE and Sudbury including direct route to health centre / hospital.
- 14. Post office very important for the elderly. Buses could run more frequent too.



- 15. Burglary
- 16. More teenage things would be good. I personally went to a village meeting to ask about more recreational things for teens and instead we got lots of young children areas which is not fair as teens have nothing. They never should have moved the park from the village hall.
- 17. Flax Lane The increase in through traffic is dangerous to pedestrians and the size of vehicles (following satnav) is completely unsuitable for the size of the road. This is an immediate problem and should be addressed as a priority.
- 18. Anti-social neighbours are not stopped from playing music and shouting into the night.
- 19. Since we moved to Glemsford vandalism and anti-social behaviour seems to have declined. It seems comparatively trivial, but the issue with greatest impact on enjoyment in this village is dogs fouling on pavements and footpaths.
- 20. Groups for older generation, parents and babies.
- 21. Inappropriate speeding
- 22. I find illegal parking an issue. Along Brook Street around the bend/junction to Crownfield Road, and also at the end where people park opposite the 'T' junction on Bell Lane.
- 23. The village needs a full time café with access to public toilets. It could be incorporated into the proposed village hall development.
- 24. More activity for everyone to do. Asking the teens and children what activity they would like.
- All of it can be an issue, there is no way to decipher from just one. Litter and dog fouling have been happening for years, there are bins around for it but people are lazy and cant be bothered. Crime wise is coz young people are bored and so are some older generations. Bring more activities into the village. Stop putting them outside the village, provide easier access to them.
- 26. More activities (sports |) for people to join.
- 27. How much money has been wasted on this survey which could have been used for something less wasteful of time money and energy? Save the trees.
- 28. Roads into the village not adequate for the amount of housing.
- 29. Dog fouling
- 30. Parking and speeding
- 31. Police presence is a big problem and the lack of things for school kids to do. E.g. 10 16's



- 32. Transport A lack of transport out of the village to anywhere and even worse getting back especially in the evening and later in the day. Hospital transport/access especially.
- 33. As more and more people are moving into Glemsford I feel as it is a village all roads should be governed to 30 miles an hour and in some cases where there is a school or on an estate it should be 20 miles an hour. A new estate has been put up near Schoolfield which has never been finished properly and it is a disgrace to the village. In Highbank there is a transformer with a broken gate easy access for children to get in coz they go past it when going to the play area.
- 34. People not picking up after their dogs.
- 35. More dog bins located around the village
- 36. I believe the biggest issue to be burglary. I myself have not been a victim of theft but I know of three people in the village that have had their homes broken into / had belongings stolen from under their noses. There must be a deterrent for this.
- 37. Parking within the village
- 38. Post office
- 39. Car parking and traffic speed. The green areas in Schoolfield could be cut back to allow for cars to park making it much safer for children to cross roads to the park and allow large vehicles to pass safely. Speed bumps should be used to slow speeding cars for the safety of the children and older people.
- 40. Very limited transport to clubs outside village and expensive bus fare before cost of club. My child does nothing.. More affordable activities for adults fitness classes/dance classes that people can afford to go to. Council runs classes or did in the past, in other district. Children that are sensible can't wait, or join in, if parent/carer has no one to look after them. For those of us who rely on the foodbank, especially during winter with high bills, £5 £8 per class is not an option sadly. Child care leading to availability for employment, using public transport. The own car and no longer trapped with no future and no hope. Glemsford really is a dead end for single parents who do not/cannot afford to run a car. No prospects. No way out. A beautiful prison.
- 41. We need the post office for the village, especially for the elderly and businesses to pay in the takings safely.
- 42. Absolutely terrible. Hobbs Lane, Park Lane and Flax Lane awful for litter. Always dog fouling on paths (even outside the school) and nobody seems to pick up on playing field. Speeding, litter, dog mess on paths and playing field ALWAYS.
- 43. Litter, Flax Lane is often full of empty cans, food packaging! There are not enough signs of warning.
- 44. More for teenagers e.g. drop-in café bar. Youth club should run throughout the school holidays. Ridiculous for it to close when it is needed most.



- 45. Being a dog owner I do get annoyed when you see dog mess on the floor from inconsiderate owners.
- 46. Dog fouling is a big problem throughout the whole village.
- 47. Important that we keep bus service, post office, shops, pub etc.
- 48. Preserving the natural environment surrounding the village.
- 49. Village identity. Glemsford has an interesting historical past. A village identity would give those who live in the village a sense of pride which can only be good for the village and its morale.
- 50. It is noted that litter etc is cleaned up at one end of the village but none cleaned from Hunts Hill downwards!!
- 51. Litter and dog fouling on the public footpaths leading from the village is disgraceful. Plenty dog bins available. Not pleasant for walkers or employees walking to work at Avent. This is anti-social.
- 52. Dog fouling
- 53. We would like to keep the village as a village and not be over-developed. Not to lose its character.
- 54. Overdevelopment of the village with large amounts of housing development ruining the landscape and overstretching the facilities of the village and causing more traffic.
- 55. Parking as mentioned previously, cars/vans on junctions, pavement and paths!
- 56. Dog mess on paths, even had somebody put a bag of poo in my blue bin (untied bag)
- 57. I don't feel like enough consideration is taken into preserving the environment. Through the facilities already here, but also by what potential things may be added to village, we need to protect the wildlife and fields/tress etc.
- 58. Improved upkeep of our greens and paths. More frequent grass cutting.
- 59. I have not really experienced any specific issues in the village. As a busy family with both parents working full-time, who live towards the edge of the village, other than popping up to the shop or park/playing field we don't do much else in the village. Our children do not go to school/nursery in Glemsford.
- 60. I have heard of a lot of break ins to vehicle occurring in the village over course of the last few years (including one of our own) better CCTV at6 night time.
- 61. Burglary
- 62. Dog fouling on footpaths



- 63. Parked cars obscuring exit, entrance, sight from side roads.
- 64. Adequate facilities for young people and teenagers is desperately needed in Glemsford.
- 65. Better bus service for teenagers to get in and out the village to give them something to do!
- 66. Hedge grooming on blind junctions summer season.
- 67. The requirement to increase the number of place available at the village school.
- 68. All of a sudden there is so much housing development in Glemsford the past two years will we still be classed as a village?
- 69. Dog mess is a problem. If one has a dog it is up to them to clean it up not leave it.
- 70. Bigger surgery and parking next to village hall? Also would create more of a centre to the village.
- 71. Roads, parking in the village
- 72. Loud music played after 12 oclock pm in the garden.
- 73. Curbs especially for buggies and wheelchairs
- 74. Teenage drug taking behind village hall!!
- 75. Total ban on parking in Shepards Lane, 30mph in Shepards and Plumb Lane Street.
- 76. We need a better bus service as not everyone drives. Many people start work at 8am and are unable to get bus until 8.20 which limits job prospects.
- 77. Theft
- 78. As a dog owner we are very careful about clearing up after our dog has fouled when out. This seems to be rare in Glemsford despite the dog bins that are visible and emptied it would appear people just don't bother to use them. I think the facilities are fine, people just don't pick it up.
- 79. Anti-social behaviour
- 80. Improved street lighting would feel safer walking around the village at night.
- 81. Closure of the post office. I know it says it is temporary but it is a big problem for everybody having to travel.
- 82. Parking/driving is a big problem, from parking on footpaths to blocking junctions. There will be someone hurt soon.



- 83. Parking cut up the grass areas and put parking bays in safety is paramount getting really bad around Cherry tree school field and most of the village you can never drive on the correct side of the road.
- 84. No mobile phone signal for Orange/EE for last nine months.
- 85. Parking on verges lifting grass and using other people's driveways as access.
- 86. A greater police presence.
- 87. I think the roads definitely need to be widened and keep maintained (ie pot holes and the fallen road on Hobbs Lane) and if more housing the roads need footpaths added, possibly all the way to Melford so walking or cycling would be safely able and extra lighting.
- 88. Public transport
- 89. Parking
- 90. Burglary
- 91. Over development
- 92. Dog fouling in the fields walkers use the fields for walks as well.
- 93. Over development
- 94. Parking
- 95. If development has been agreed on Skates Hill would it be better if widening the road was part of the agreement.
- 96. 5 Day youth club and youth leader
- 97. We feel that there should be much, more parking controls within the village. We increasingly find that we are having to pull out of blind turnings or are on the wrong side of the road, due to inconsiderate poorly positioned vehicles.
- 98. Parking and the amount of cars people needlessly own, too many households in Glemsford take the complete piss having 3 and 4 cars but only room for 2 on their drive. Something needs doing.
- 99. Transport! Not everyone drives and elderly rely on bus to get out. Heard recently from some people (ourselves included) that have thoughts of moving somewhere with decent transport. Cannot even get to Sudbury on Saturday now, which means town missing out and only 4 buses a day.
- 100. Parking on the roads
- 101. Police response times



- 102. Condition of the road and pavements is rather poor with lots of holes and ruts. Just patching these is not good enough. Also hedging is rarely cut back requiring people to step into the road in some places around the village.
- 103. Speeding vehicles: especially Hunts Hill/Egremont Street/ Skates Hill
- 104. Car parking particularly along central route through village.
- 105. One issue that upsets me a lot on a daily basis is dog fouling, I walk my children to school and regularly pass over 10 areas each day. And if it's dark we have been known to walk in the road to avoid. Not sure what can be done but always a topic to be improved.
- 106. More for families and young people to get involved with in the village and integrate more. Also make much better use of the playing field and bring back the youth football team's boys and girls.
- 107. Glemsford needs to make a stand so that the new houses are not just snapped up buy property speculators to rent out like recent developments. Have a criteria and ensure there is an influence on the builders rather than they just be a profit driven. When a society cannot provide housing options to its residents then it's a poor reflection if everyone young has to move away.
- 108. Dog fouling is a big problem across fields, pavements and play areas. More dog poo bins would help and free dog poo bags around the village!
- 109. The issue of extensive housing developments being built on farmland concerns me most in Glemsford.
- 110. The abandoned 'Old Chinese' restaurant should be sold or converted. Eyesore.
- 111. Vandalism is usually an outcome of boredom. We have very little for our young people. No football, cricket, netball, badminton. Meeting place to get together with friends. We have a very poorly kept and equipped park. Could follow Gt Waldingfield and have a community garden. Raise money for sport and meeting pavilion. They have no transport to get to and from the village. We should be acting now.
- 112. Roads are not able to cope with traffic volume. This is getting worse with increasing population.
- 113. Catching people walking dogs on footpaths and not cleaning up the mess they make because no one sees them so they don't care about picking it up.
- 114. The pubs in Glemsford are not very nice. There is nowhere within walking distance to go for a nice meal (except Wong's). Compared to L. Melford and Cavendish these villages are far superior. Glemsford needs a good pub/restaurant tea room or coffee shop.
- Dog fouling is a big problem. We need more bins and emptied reg. I own 3 dogs and am always taking extra bags and clearing up after other people.



- 116. There needs to be more done about the drug issue around the village.
- 117. Cars parked on pavements.
- 118. Litter
- 119. Lighting in the streets of Glemsford is not at all adequate. People walking in poorly lit streets
- 120. A greater police presence i.e. put police on the beat daily.
- 121. Vandalism
- 122. Village cleanliness. Foot paths and alleyways not cut back.
- 123. Hedge rows, communal car park tidied e.g. overgrown, rubbish.
- 124. We could do with more amenities small amount of shops but no petrol station and have to travel a long way for one. Glemsford is a lovely village and has all required.
- 125. Golding Way sanctuary housing needs addressing. This is becoming noisier and more antisocial.
- 126. The bus service. As a mum of 2 children and no driving licence the recent change to bus times has made it difficult for us to see family members who do not live in the village, especially in between school runs. The price is also ridiculous considering it is £6 return for a 15 min bus journey, but is the same price from Sudbury Hadleigh which takes 45 minutes!
- 127. Need more parking for houses that do not have parking.
- 128. Over development is contributing to most of the issues raised in this questionnaire.
- 129. Village amenities critical to maintain and enhance facilities in the village within walking distance for residents.
- 130. Dogs fouling had found dogs mess in my front garden told the dog owner looked at me as to say F O
- 131. Litter and dog fouling but bins (dog) do get vandalised.
- 132. The mobile phone signal for EE is now very bad in Schoolfield (up until about nine months ago it was very good). This problem needs to be addressed as it could be a problem if you cannot be contacted in an emergency.
- 133. Inconsiderate parking all-round the streets of Glemsford on corners, opposite busy junctions, on pavements blocking entrances. Drivers no longer respect the Highway Code.
- 134. Bad parking eg the road outside Spar. It is virtually impossible to see and pass safely. The same can be said for elsewhere in the village and people speeding adds a further concern.
- 135. Preservation of the village character and the surrounding countryside.



- 136. More for the young ones growing up to do. After school activities to cultivate a growth mind-set.
- 137. Dog fouling. Post Office not open. Needs to be brought back to working again plus transport ie buses.
- 138. We need the post office open again.
- 139. I haven't had or heard of any crime since coming in to the village three years ago. The only thing is there is a huge amount of dog fouling in the village. More than I ever saw living in BSE!
- 227. Pavement access, ie overhanging hedges cut back and stone and other debris removed. Also parked cars on pavements allowing pedestrian and mobility scooter access.
- 228. Parking around the school and the doctor's surgery is very dangerous at peak times.
- 229. Parking of vans/commercial vehicles near the junction of Brook St and Bells Lane as it makes it potentially dangerous to pull out from Brook St.
- 230. A more regular bus service, recently the bus service has been changed and fewer buses go to town and none on a Saturday at all. I myself work and I have had to lose money because of this.
- 231. Car parking on roads
- 232. Litter
- 233. Roads dangerous. Too many new developments and not enough council housing for locals.
- 234. On road parking. This has become a serious hazard.
- 235. The problem that we have is no knowledge of what goes on in our village as no newsletter or any contact from parish or councillors or MPs is received so we probably miss out on services that are available.
- 236. Dog fouling. New approach needed, parish council has consistently failed to address this, warning notices just not good enough.
- 237. Vandalism and dog fouling.
- 238. Burglary there are lots of residences in the village, some of which are isolated, so it could be a problem not just houses, but outbuildings, sheds etc.
- 239. Dentist in village.
- 240. Expansion to the village is a concern as we previously moved here from an area that had been vastly built on which led to more crime, pollution, anti-social behaviour, traffic congestion and so eventually lost the close community spirit. We moved here because it was a very quiet and friendly village.



- 241. Dog fouling.
- 242. Parking issues especially illegal parking on a junction in particular Brook St/Bells Lane Fair Green.
- 243. Littering
- 244. At present time, no post office facilities and should be rectified.
- 245. I hate littering, it is unnecessary.
- 246. Dog fouling is an issue in the village. I see it all over the public footpaths. I used to have a dog and never let it mess on footpaths etc. Litter is also a problem in the access roads to the village.
- 247. Large scale housing developments must include amenities shops, community support facilities etc. It must also comprise a range of housing types flats, bungalows etc.
- 248. Development of Glemsford as a compassionate community. People look out for each other and make what's strong stronger.
- 249. Additional housing development requires expansion of existing school places and access to Doctors and better public transport facilities. At present Glemsford is full to capacity.
- 250. Lack of public transport.
- 251. Litter no litter would make village look more appealing.
- 252. General access along main road due to parked cars making passing in some places risky.
- 253. Dog fouling
- 254. Burglary we are concerned about a number of burglaries that we have heard about in the village.
- 255. Litter
- 256. D9 All concerns for us as want village to be as safe as possible.
- 257. Park and groups/clubs for older children and teens.
- 258. Around here at Long Pastures, street lights go out at 12pm. Of the last six issues, burglary and vandalism concerns me most.
- 259. Lack of maintenance to alleys and pathways.
- 260. Speed of traffic travelling through the village.
- 261. Road edges to be repaired. There is one that has needed to be done for over 5 years!



- 262. Parking Im all for double yellow lining all estates, it's a major eyesore, dangerous for children and drivers. If you cannot park on your own property you shouldn't own a car! Alternatively move!
- 263. Burglary
- 264. The village hall as it is a central point of contact and functions for all in the village.
- 265. Burglary. Lots of break ins recently. Lots of van and car theft in the area.
- 266. Adequate planning for growth including house cross tenures using existing brownfield and infill sites where possible. Growth should be sustainable and proportionate to existing infrastructures including roads, education and other services.
- 267. Speed bumps in some areas or over length of village.
- 268. With more housing coming to the village the roads must be looked at more houses means more cars the location of the village people need to drive to get anywhere public transport is not good enough as it is at the moment and is not likely to improve.
- 269. Increased urban sprawl will destroy the ambience of Glemsford.
- 270. Neighbourhood watch scheme.
- 271. We need a village hub/centre, containing meeting area (could be new village hall) sports hall, playing field needs to be upgraded and changing facilities to be included give us somewhere to be proud of.
- 272. Building on greenbelt and over-development of the village that is unsympathetic to our surroundings.
- 273. Grass and greens maintained. Roads need to be resurfaced esp Bells Lane.
- 274. Groups of kids/teenagers shouting and drinking out on the street, I have a young child and double glazing yet we can still hear the abusive language and swearing.
- 275. Clearing of footpaths (weeds and stinging nettles).
- 276. Speeding through the village. Parking.
- 277. I would like to see more easily accessed information. I have lived in the village since 1982 and was unaware of most of the clubs and activities available. Haven't had a newsletter in many years didn't even know about notice boards. Not everyone has internet access, especially some elderly and more vulnerable residents. Maybe the parish council could promote the community feel of the village more.
- 278. The village requires a lot more affordable housing, to keep its young and not encourage second homes.
- 279. As I live more towards the bottom of Egremont Street the three that I haven't scored don't affect us probably as much as the more built up area towards the top of the village. There



are not enough yellow lines in the village, especially on the sharp bends it is very dangerous especially the one outside Wongs Cherry Tree and one opposite Hunts Store people park right on that corner.

- 280. Pavements in the village are in a bad state of repair. Road surfaces in poor state of repair.
- 281. D6, D8
- 282. Congestion and traffic problems should be addressed which should lead to more thought about further developments.
- 283. Access roads to village, parking and lack of public transport.
- 284. Indiscriminate parking on road corners ie corner of Chequers Lane, corner of Springfield Meadows, corner of Bells Lane, in fact all junctions. These areas require red lines enforced by the authorities. It is an accident waiting to happen.
- 285. Parking at junctions!!!! Although not illegal to do so, any car parked opposite or within 10M of a junction can be causing a fineable obstruction to visibility of other road users, and yet nothing is done about it. Hedges along pavements and at junctions should be kept back off of the path.
- 286. I gave D9 a score of 5 because they are things I wouldn't want to see increase. However, I am not very concerned because they're rife in Glemsford now but concerned that they shouldn't be.
- 287. One has no confidence in the police or their response.
- 288. Vandalism we need more police presence.
- 289. Burglary
- 290. I live next to the school I have done for 20 years! I would really like to slow the traffic down with speed bumps, I always hear cars zooming past at all hours. They can't be so costly to put in but would stop this speeding.
- 291. Parking and visibility displays.
- 292. Burglary/vandalism/car crime I can't choose just one of these as a main concern, as these three are all of equal concern not having lived here for long enough to know which crime may be the biggest concern to the area.
- 293. Dog fouling.
- 294. Speeding!
- 295. I question the description of Glemsford as a village: with prospect of considerably more housing stock we will become a town.
- 296. Very uneven pavements. No flashing speed warnings. Areas with no pavement at all (where residents have co-opted what should be pavements into their own gardens or even park



- their cars, forcing pedestrians to cross the road in very dangerous spots particularly near Hunts Hill store)
- 297. A greater police presence
- 298. New development without infrastructure. The so called 'core' of this village has been over estimated for years and still it's expected to cater for more and more people.
- 299. Anti-social behaviour
- 300. More for children to do parks, activities, or better bus service to town where there is places. Speeding!!
- 301. Grass cutting
- 302. I moved to Glemsford in 2001 and I have seen and been in the middle of lots of house building. I choose to live in a village therefore I want to carry on living the village life. I say no, and a big no to no more building our roads can't cope and nothing like our school or amenities seem to get updated. (No to more housing)
- 303. Car crime but this is a problem in most villages.
- 304. More activities for teenagers often there is a large group of them roaming around the village looking very bored.
- 305. Widening of main access roads to accommodate increasing traffic flow in and out of village.
- 306. Dog fouling. 2 children and dog owners. Constantly find dog mess even though bins are provided.
- 307. Speeding
- 308. More activities for adults! Those with or without children. You are right to point out the lack of café, coffee shop etc. The pubs are a little run down/unwelcoming. There are very few places to sit, eat, socialise without taking our business to Melford, Sudbury, and Hartest etc....
- 309. Traffic/parking around the village.
- 310. Vandalism of the silk factory.
- 311. Dog fouling. It's a shame we cannot catch those who allow their dogs to foul our pavements.
- 312. Proposed development issue, surely with employment issues around Glemsford why build so many houses? Glemsford doesn't need to get bigger just better for the people already here.
- 313. Parking in the village. Planning permissions granted do not insist on enough parking.
- 314. Extra recycling facilities.



- 315. Glemsford should remain a rural village, not turned into a small town. Glemsford should not be urban.
- 316. Bus service Saturday service has completely stopped. We need more public transport. Too irregular and not enough!
- 317. Planning! Should be more in the control of village population and ensure the character of the village community be maintained. Should be diverse mix of homes to ensure a population mix to contribute to village life.
- 318. Drugs
- 319. No police presence I have seen. Maybe a drive through at the same time each week.
- 320. Parking.
- 321. Very bad car parking
- 322. More for teenagers to do without this the teenagers will be forced into getting together on streets and anti-social behaviour.
- 323. Parking and access into/out of village.
- 324. Parking along the main road through Glemsford it should be yellow lined. Also the grass just opposite the Chinese (albeit slightly lower) could be made into parking spots. Also Tye Green needs slightly shrinking to enable more cars to park at the top and at the side nearest to the Cherry Tree. Then double line the road passing the Cherry Tree also reduce traffic there to 20mph maybe with a bollard. This is lethal for good drivers but for the less experienced can only cause carnage soon.
- 325. More information direct to householders, regarding what is going on in the village, for them and to help them to enjoy and feel included in village life.
- 326. Despite signs located around the village there are still numerous resident dog owners that fail to clean up after their dogs.
- 327. Having facilities for young people to do and keep them safe.
- 328. I think that future housing development should be firmly controlled, and kept to a minimum. Residents more widely consulted and kept informed.
- 329. I feel the village is adequately equipped with dog waste bins and that most dog fouling is due to the owners who can't be bothered to clear up after their dogs. Facilities have been provided for teenagers in the past ie the skate park, but these all too frequently end up vandalised.
- 330. I have a 2 year old and I feel that the parks and groups offered at the village hall provide plenty for her to do though there isn't much on offer for older children/teenagers. I would like it if the park tucked away on Kings Road was enclosed as there have been numerous times where people have had dogs off lead in that area which have then ran over to the play



- area, maybe this could be fenced off for security and safety for the children who use this park.
- 331. Parking on road. Last Xmas (2017) my husband's car was hit (his is a private hire/taxi driver). The cars parked on Bells Lane/Brook Street meant the car that hit my husband cut the corner. This is a common problem with parking. It's dangerous and also my husband business suffered and we had to let our local customers down. The other car was not from Glemsford and so unaware of parking problems here.
- 332. There needs to be more for the children and young people to do in the village. This will reduce the risk of anti-social behaviour and vandalism. The village hall could be used more for groups and social activity.
- 333. Parking. Most homes do not have adequate off road parking. Park Lane and Hobbs Lane must be widened to facilitate the increase in traffic.
- 334. D4 CCTV Deterrent.
- 335. Public transport is totally inadequate for Glemsford.
- 336. Resident police officer but as the moneys run out perhaps a PCSO to walk the streets instead.
- 337. Potholes and general state of the roads through the village especially outside the Spar.
- 338. Litter. Food wrappers down Hobbs Lane disgusting sometimes. Thank goodness for volunteers.
- 339. Dog fouling. I consider this to be anti-social and should not be allowed.
- 340. Parking facilities, especially on main roads through the village.
- 341. Dog fouling/litter. More needs to be done to control dog fouling (maybe a dog warden). School children in the village should be taught about dog fouling (maybe a school litter pick would be a good idea at various intervals).
- 342. Though it seems to have reduced of late, very noisy and speeding cars and motorcycles are a problem late in to the night. Occasional late night police presence would be great.
- 343. The doctor's surgery is under immense pressure already with the small increase in housing. It not only serves Glemsford but the surrounding villages as well.
- 344. To improve the look of the village, such as flower baskets and troughs. Facilities for lights on the greens.
- 345. There needs to be more dog poo bins and bags made readily available for dog walkers. Dog walkers are continuously failing to clear up after their dogs! I cannot mention just one of the most important. All the issues mentioned in the previous question are causes for concern in the village.
- 346. To have a safe village



- 347. There has been an increase in dog fouling which makes it more difficult for parents with pushchairs and elderly and disabled to use footpaths and pavements. There are also certain areas of Glemsford where groups of teenagers hang around which makes many feel uneasy, particularly if alone.
- 348. I feel safe here in my road, hence low scores. Parking, with more houses being built this brings more cars. Many cars parking on road sides cause an issue, especially when walking my children to school.
- 349. Vandalism
- 350. I think housing is a big issue, the need for good housing well planned out and not too many at once.
- 351. Overcrowding for doctors surgery. Appointments are ok at the moment but will be impossible if many more people are on the local lists.
- 352. More strict on parking, seems car can park anywhere, causing issues on main road through Glemsford.
- 353. Parking! In bends and junctions.
- 354. Roads could do with widening. Large farm vehicles bombing up and down.
- 355. Sewerage Bad!
- 356. A large scale housing development is not needed in Glemsford especially social housing as there is no employment and the infrastructure is poor. Housing developments are more suited to areas with employment i.e. towns.
- 357. Responsible dog owners fouling on footpaths and pavements has a poor reflection on the residents of Glemsford. Perhaps more bins and even bags could be provided.
- 358. Tye Green road leaving into Cavendish Lane speed waiting for and accident to happen!! 30 miles speed limit, at least 50 60 or more cars, vans speed through. Need to be monitored and warnings given. Also by the school only 20 miles but so many vehicles go fast 40 + 50.
- 359. The increase in development and the lack of infrastructure. Glemsford has and is continuing to expand, housing developments continue to spring up, parking and roads cannot cope with the increased traffic, it is difficult in some areas of the village to drive through, this will only worsen as further developments continue.
- 360. No more housing estates
- 361. Building more houses is ok but there is the issue of parking and as there is no proper infrastructure something that is needed. The school and the doctor's surgery wouldn't be able to cope. And there is no Post Office which for a village this size we need there is no consideration for elderly people who don't have a vehicle to get them to other post offices.



- 362. The police presence in Glemsford is virtually non-existent. This requires dramatic improvement including police walking the beat after dark. Policing is a disgrace in rural areas of Suffolk.
- 363. Speeding along Lower Road. Part of youngsters race circuit
- 364. Dog fouling
- 365. Burglary police presence and fast response.
- 366. Speeding
- 367. Doctor's surgery does not have enough appointments. We have both had issues and ended up in A & E due to lack of appointments.
- 368. The village needs good public transport to ensure that those without their own transport do not become isolated and deprived of occupational and social opportunities.
- 369. Car parking and main route through and into village
- 370. Speeding control ie road bumps and camera
- 371. Post Office Lane is a well-used footpath and is very overgrown, untidy, full of potholes.
- 372. Speed cameras in Bells Lane to stop cars, buses and lorries speeding up and down Bells Lane.
- 373. Extra recycling facilities.
- 374. The boy racer's using Glemsford as a race circuit.
- 375. Dog fouling is bad in Glemsford
- 376. Post office services essential for elderly, disabled. Currently suspended isolating older members of community.
- 377. Vehicle speeding especially in Bells Lane. Much too prevalent and dangerous. Frightening to be a pedestrian. Needs action.
- 378. Teenagers need more activities to occupy them now that the County Youth Service is cut and there is a risk of getting involved in Country lines drug activity.
- 379. Concerned about the closure of pubs where people come together to socialise. Also concerned about derelict buildings on the main road of the village like the old Wongs.
- 380. Concerned about the future large development at Lower Road.
- 381. Dog fouling on the pavements is a real problem, particularly near the school.
- 382. Burglary increasing population and hard times for everyone impels impoverished people to resort to crime mostly theft. Therefore a police presence as 5 8 years ago may deter some would be villains.



- 383. Public transport
- 384. A fully functional post office is essential. A coffee shop would be welcome. A small museum to celebrate Glemsford's history.
- 385. Litter is an enormous issue despite gallant efforts and litter picking groups much appears to be discarded through vehicle open windows. Vandalism especially in the vicinity of the old silk mill also but shelter is subject to some making it unattractive for the village
- 386. Car parking, most houses do not have, and cannot have, areas to park their cars. A community car parking area would solve much of the road congestion in the village.
- 387. More for teenagers to do most of the section D9 might improve if more social events, or access to those in Sudbury made easier to access for teenagers. Public transport costs are often out of reach for some families.
- 388. Have often had dog poo on the side of my front garden.
- 389. Hobbs Lane, to have the road widened would be lovely, there's no easy access for lorries, buses, tractors etc etc, it can be a nightmare driving up to Glemsford.
- 390. Lack of police presence
- 391. Parking
- 392. Motorists speeding through the village need more slow signs maybe speed bumps.
- 393. Tourist attraction needed eg museum or country park
- 394. Just me? Anti-social behaviour. It could lead to general further deteriation of the village.
- 395. With Glemsford no longer a village it is now a slab of houses and roads. Wild life have moved away and I wish I could fly off with them. No enjoyment driving through the village cars parked everywhere, a pretty village ruined.
- 396. Limited access for traffic through and in/out of our village.
- 397. Roadside parking. Accident waiting to happen esp outside doctors.
- 398. Parking on corners is very dangerous and will lead to a very bad accident, especially on Kings Road.
- 399. A greater police presence.
- 400. Inconsiderate parking, and too many vehicles parked on most of the roads in the village. So that many places it is not safe for other drivers and pedestrians, especially if some drivers are going too fast.
- 401. Will the sewage farm be expanded to cope with increased demand?



- 402. Roads surface and widening
- 403. Litter and dog fouling
- 404. Ante social behaviour
- 405. I find Suffolk recycling confusing and not as inclusive as other areas I've lived in. Easier = more people will recycle.
- 406. Burglary no police.
- 407. Speeding through village
- 408. Litter
- 409. Introduction and maintenance of CCTV would provide a cost effective solution (long term) for the security and safety of residents.
- 410. Safe pedestrian access to the village along Skates Hill. Families living on Skates Hill; cannot walk into the village safely.
- 411. Parking. Health services
- 412. Litter is a constant problem on access roads into the village.
- 413. The village generally looks untidy and unloved. Litter is a problem and drains often blocked and road surfaces are very patchy.
- 414. There is a small stretch of Lower Road at the bottom of Skates Hill that urgently needs either pavement or enforcement of the speed limit. This stretch is frequented daily by dog walkers and sometimes children walking down to the river. The particular junction has seen many accidents. Our home is the Three Turns which has had crashes inches from our living room, people drive at high speed into Skates \hill. My husband and neighbour have nearly been knocked over twice. I've written many emails about this to no avail. What will it take to get something done?
- 415. Bus service
- 416. As I live on main Lower Road, traffic speeding seems apparent. Maybe more speed checks on this 40 MPH limit could be carried out near the factory. We do not have footpath access.
- 417. The dreadful eyesore at the end of Chequers Lane, namely the derelict Silk Mill.
- 418. If I could make just one addition to the facilities in Glemsford it would be a quality hotel capable of taking about 100 guests. Currently the only visitors are those with friends and family resident and caravanners. A hotel would attract other tourists and persons would bring finance into the village and surrounding area.



- 419. Dog Fouling is an extreme problem on footpaths popular with dog walkers not all walkers of course but it is a long lasting health and social concern. The council provides sacks and disposal bins but some folk persist with their lack of responsibility
- 420. Over development. Bringing in more cars, very dangerous in mornings, there is no zebra crossing for school children, this should have been addressed when school was enlarged and with building of more homes.
- 421. Hedge needs cutting back on Cavendish Lane
- 422. On street parking
- 423. Dog fouling
- 424. Litter on approach roads to the village demonstrates a lack of care from the authorities and lack of personal self-respect from inhabitants. Glemsford can never improve while it advertises itself to all who visit as an untidy village.
- 425. Need to keep a village atmosphere no yellow lines etc.
- 426. Developments not taking consideration of the available infrastructure of the village schools, sewage, doctors etc would be overloaded.
- 427. Speeding along Lower Road
- 428. Some road need to be widened due to more traffic.
- 429. A better play park for infants, ours is very poor compared with some villages and this one is getting bigger all the time.
- 430. Speeding
- 431. The state of the roads and lack of public transport
- 432. There are not enough dog litter bins around Glemsford, that's why people are not picking it up, because they have to carry it round with them.
- 433. Roads need to be widened for easier access with so many cars being parked at the sides of roads resulting in difficulty getting through.
- 434. Traffic and speed of vehicles through the village should be kept to a minimum. Glemsford seems to be getting to over-developed and overcrowded to remain a village. If overdevelopment continues I would consider moving.
- 435. The facilities available currently in the village suit its needs, as a village. Increasing the population of Glemsford will have a negative impact on all these issues and we will lose our village feel.
- 436. Dog fouling. Despite being well provided with dog bins, there is still a lot of fouling.



- 437. Dog fouling it's a huge issue, paths, driveways etc are often covered and gets worse in the winter months.
- 438. WE moved into the area 4 weeks ago so don't have a lot of experience to go by most of the issues are issues everywhere e.g. greater police presence. Most important I think is more for teenagers to do. But then I don't know all the facilities anyway being new to the area.
- 439. Poor state of roads in village
- 440. The post office has been out of service for a considerable time. Due to the post office not provisioning a new system in order for the service to continue the proposal has informed he has been given no date for these improvements. The post office is vital to the village, particularly the elderly or disabled residents but no-one seems to care about it at all.
- 441. Anti-social behaviour including: allowing pets to foul parks, or roam (cats), fireworks usage throughout the year, unkempt land, party noise, loud music during summer nights, motor vehicles racing through the village, boy racer exhaust noise, intrusive lighting from neighbours, screaming kids, rubbish put out for collection that remains on footpaths, old-iron collector disturbing the peace on Sundays....
- 442. Better public transport. Improvements to buses reinstating Saturday buses to Sudbury. Glemsford can be an isolated place if you don't drive. If it was ever possible I'd also support the reinstatement of the railway station as the loss of the local railway has led to long term problems for the local economy and accessibility to other places out of Glemsford.
- 443. Burglary
- 444. The poor street lighting really does deter me from going out to village events (e.g. history society) during the winter evenings.
- 445. Parking
- 446. Improvements to the access roads and clearance, especially in icy/snowy conditions
- 447. I do not want any more houses to be built. If the village becomes any bigger it would be a small town. We have already had a large number of houses built. There isn't enough infrastructure, transport etc for more people. The school is full. Crime would most likely increase.
- 448. More care should be taken with the upkeep of our green spaces. I could not walk down a path because it was overgrown with nettles. Also having to duck under branches. Dog fouling especially on play areas. (What could be done about this?)
- 449. Car crime I was a victim of theft and my car was outside my house.
- 450. The village is very well provided with litter bins and dog fouling bins. I feel dog fouling is less than it used to be but littering seems to be getting worse.
- 451. Dog fouling in this village is awful. The times we have to clear up dog poo outside our house! All on the walk to school the poor mums end up getting it on buggy wheels or the children stand in it then take it into school on their shoes.



- 452. People clearing up after their dogs, there is no reason not to clear up, you may miss one or two on grassed areas, but never on the pavements. Path access is very bad throughout the village at the top of 2nd Avenue you cannot use push chairs and the wheelchairs have to go into the road
- 453. The roads need repairing they are awful opposite spar. All dog should be on a lead in the village so dog fouling can be cleaned up.
- 454. I think it is important residents are proud of the village and keep it clean and tidy. Also assisting older neighbours.
- 455. Severe lack of police presence
- 456. Wheelie bin blight
- 457. Poor street lighting means that you cannot see where dogs have fouled.
- 458. Speeding
- 459. Not enough for the youngsters to do next to no facilities, no police presence.
- 460. Inadequate bus service. Closed post office. Dog fouling
- 461. Bigger car park for cars parked on the roads and on the paths.
- There does seem to be a lot of new building going on, is there any way we can stop arable land being used for housing?
- 463. I feel that the doctors surgery should be moved to a more suitable area (i.e. the village hall)
- 464. I would like free green bin collections
- 465. Litter is a problem seems to be a fair bit of fly-tipping and a lot of rubbish dumped where some park to consume their MacDonald's or Kentucky.
- 466. Dog fouling irresponsible use of dog poo bags in spite of adequate bins in the village as well as dog fouling per se.
- 467. Litter it just makes the village look untidy.
- 468. More police presence to deter petty crime/vandalism. Never see a police person on foot patrol within the village.
- 469. The post office is very important to all the village if your elderly or cannot drive for getting money, stamps and all connected we do miss it.
- 470. Burglary may be of concern to older people living alone.
- 471. Dogs muck all over the place and litter is shocking (good lot of bins for both) but people don't use them.



- 472. Not resided here long enough to know the area.
- 473. Concerning litter and dog fouling all it takes is more bins to be placed everywhere!
- 474. There are no pathways on Lower Road and Skates Hill, my children had to walk along the road when dropped off of the bus. The road is very busy and dangerous for all that walk along Lower Road up into the village.
- 475. Something needs to be done about the way cars are park all the way down the main routes through the village, as this is a major accident likely to happen.
- 476. Dog fouling in fields.
- 477. As a dog walker myself, I have recently found that dog fouling has increased in certain areas, where owners seem unable or unwilling to clear up deposits. It seems the bigger the dog, the larger the deposit that isn't cleaned up. We are reasonably well served with dog litter bins in the village, so there is really no excuse. It is a legal requirement on any public footpath.
- 478. Dog fouling still a few people who don't clear up after their dogs, no need these days.
- 479. Litter is a major problem. People in cars especially seem to feel obliged to throw litter out of the car windows, especially on the roads surrounding Glemsford.
- 480. Police presence
- 481. Theft from property The lack of police care and support. We know of 2 cases where they closed the case and did nothing to solve the case. They never even attended the scene or again showed any empathy with the victims.
- 482. Littering in the village is bad. This and the throwaway society is spoiling the countryside.
- 483. Transport
- 484. Dog fouling
- 485. On road parking, people park anywhere on corners, near crossings whether legal or not.

  Nothing is ever done about this. This is most important from a safety point of view, the most important issue that needs sorting in the village.
- 486. Lack of parking facilities leading to many cars having to park on the road. Eg if a car park was built on the allotments at the end of New Cut a lot of cars could park there instead of on Egremont Street.
- 487. The proposed housing development
- 488. Lack of public transport
- 489. The newest street lights are ugly and only offer a pool of light under the street lamp leaving very dark areas in-between. The lights on the main road through the village are very good



- and look nice. Would like to see these through the main street. Perhaps modified with LED bulbs, yellow not white.
- 490. Manage parking around the school. Consideration to be given to parking restrictions around the school. Consideration to be given to a pedestrian crossing along the road by the school.
- 491. Bus service and parking control.
- 492. Parking on the main route through the village is both dangerous and frustrating, and unless tackled is likely to lead to serious accidents. Suggest one way traffic through the village.
- 493. We would like to see our Doctor's Surgery / Pharmacy stay in Glemsford. Local shops stay and amenities.
- 494. Crime
- 495. Parking problems Skates Hill, Egremont Street, Lion Road, Bells Lane, The Broadway. Parking on paths. No room for pushchairs mobility scooters.
- 496. Parking on green spaces and road through village is often single lane due to number of cars esp. at the top of Skates Hill.
- 497. Communication. The Parish Council should let the people know what's going on and what they have in mind. The village needs a P.R.O. to get their ideas across.
- 498. A lot of the speeding on Lower Road comes from Skates Hill, you can hear the acceleration of the motor bikes, and cars, when they enter Lower Road.
- 499. Regarding development, I have been informed that a 25 year monitorium was placed on the Kings Road estate. The land behind, down Hobbs Lane, then to become available. Is this a better option than the current proposal for Lower Road?
- 500. My main concern is that of staying a village and overdevelopment. Brown field sites should always be used in preference to fields. My other main concern is an adequate bus service to get people to work not everyone has cars. In my opinion the village does not want any more developments.
- 501. The parking situation in the main village is atrocious. During evenings, particularly dark winter ones, one is forced to drive down the village on the wrong side of the road from Lions Rd to the top of Skates Hill. The situation worsens when there are evening meetings at the old school hall and in other specific areas no spaces left! Nowhere to duck in, no yellow lines. Egremont Street is particularly bad as is Tye Green near the Chinese Restaurant and bend.
- 502. Parking throughout the village
- 503. The frequent road closures. The post office.
- 504. Street parking



- 505. Is there any rea in the village that could be used for recycling? On a recent visit to the 'tip' in Sudbury I noticed a whole dinner service set of cups/saucers/plates etc all obviously new and unused. I was told in a very aggressive manner that I could not remove anything from a skip and the set was smashed. If the council are not very concerned and recycling then perhaps we could organize our own. I suspect many households have items that are no longer wanted but may be of interest to others.
- 506. Speeding traffic coming into the village and on all roads especially into Churchgate. Could do with local speed watch. The other big issue is roadside parking making roads difficult to navigate Skates Hill is like a slalom course most days.
- 507. Cars parked through village getting very hazardous.
- 508. There are zero recycling facilities in the village since the removal of the bottle bank at the village hall. It would be really encouraging to have a decent range of recycling bins to encourage recycling.
- 509. Vibrant community hub to encourage healthy connections amongst villagers and nurture pride and care of village.
- 510. Vandalism because there is a reluctance to investigate because of perception of damage e.g. Christmas tree, Rest unreadable.
- 511. Post Office is very important but it's closed until further notice and might not re-open.
- 512. Transport The more homes the more traffic!! Inadequate bus service, none at all at weekends. No local taxis.
- 513. Bad parking issues sooner or later there could be a serious accident caused by this.















The following free text responses were received in relation to question E 9:

#### 316 responses were received in total:

- 1. Specialist sports hall, well equipped. Badminton, soft tennis, climbing walls, Pilates, yoga, Zumba, dance. Attached to sports field would be brilliant.
- 2. Useable pavements
- 3. A café or coffee shop. It would be a nice place for people to call in and have a chat. Also a Dentist!
- 4. Coffee shop
- 5. At least three or four car parking areas spread through the village together with enforced double yellow line parking control but only in recognised risk areas such as junctions, blind bends and one side of the main through road.
- 6. A petrol/diesel garage have to travel miles either direction to get one.
- 7. I would like to see more facilities for young teens which would help keep them off the streets, help them make friends and give them a feeling of belonging and improve their self esteem but no nightclubs. Also more to do for lonely older people.
- 8. Fuel station......Be nice to not have to go to Sudbury to fill up!
- 9. Indoor sports facility i.e. sports hall gym for all ages.
- 10. Pubs that open on a regular basis and serve food.
- 11. Maybe a dentists surgery, otherwise well served.
- 12. A secure facility for dogs.
- 13. Night school classes for adults i.e. languages maths English dancing
- 14. Sports centre
- 15. A decent bus service from Sudbury Haverhill. Allow our fun fair to come back.
- 16. A sports are for older kids. The rec is too dangerous because of glass etc and is not family friendly.
- 17. Café/restaurant/pub with good food.
- 18. Post office (temp closed)



- 19. A village museum or heritage centre linked to the local history society and incorporated into the proposed village hall complex.
- 20. Really miss having a proper bakery in the village.
- 21. Dentist. Post Office Glemsford has been closed for over two months why?
- 22. Post office needs to work. Library needs to be bigger.
- 23. Cinema, sports centre, swimming pool. In these days of obesity and no buses it will keep the locals fit and active.
- 24. Larger supermarket/petrol station. It's at least 7 miles to get to one.
- 25. Coffee shop / café
- 26. More for teenagers to do (I don't mean youth clubs as this is not what they really want). Make more use of the rec with football, rugby and other such things so basically utilise the facilities we already have that are going to waste.
- 27. A café with access for all at all times.
- 28. Post office very important to the village as we have a growing elderly population and possible don't drive.
- 29. Working post office
- 30. More facilities for the older children. We used to have swings etc on the Recreation ground, this was good for building community for the young.
- 31. A leisure centre would be incredible as our village increases. I feel that an affordable facility would promote health greatly and be very much in demand considering the closest affordable facility (gym, pool, and exercise classes) is at least twenty minutes' drive. I feel surrounding villages would travel to us to use it also.

- 39. Rumours are that the post office is closing/going?? This needs replacing if they are true.
- 40. Skate park improved facilities, better Play Park for older children. Clean up the glass.
- 41. Restaurant
- 42. Vets. Self-explanatory.
- 43. Good food pub!
- 44. No opinion
- 45. A more developed doctor's surgery/health centre with more provision of services for the village inhabitants. Public transport is not only infrequent but expensive which makes getting to Sudbury a trial and very difficult for those who need the surgery the most.
- 46. More leisure facilities.
- 47. Sports hall for teenagers and adults to use. Village hall not big enough.
- 48. A good restaurant (other than chinese)
- 49. A café and bakery would be a nice addition.

- 59. Dentist
- 60. Butchers, baker, cash machine outside shops for out of hours.

- 62. Post office as not open atm.
- 63. A coffee shop, such as they have in Cavendish would be a good addition.
- 64. Setting up childrens/youth/adult football clubs offering coaching and changing facilities.
- 65. Another school, current school is full. So we need another one or current one extended.
- 66. A gym/sports hall. It is a long commute for a gym/or to play sports. I have given up badminton since coming here.
- 67. extra help for the old getting shopping in help with pension as it's all going banking now can't get cash OAP cheap food like at the fish n chip shop as they don't do that at Rumbles but they do down Sudbury.
- 68. We need a Post Office, as I am nearly 90 it is very inconvenient to have to travel to Melford weekly to get my pension, bus service poor, does not run frequently enough, have to rely on people to give me lifts.
- 69. Something for teenagers
- 70. An up and running Post Office what has happened to it? Also football teams (youth and adults) and pitches maintained all year round and possibly boxing facilities.
- 71. More help for the older generation
- 72. A functional Post Office!
- 73. Youth centre
- 74. Better leisure/sports facilities for all age groups. Although the village hall is a good venue im not sure it has the capacity for indoor sports. Apart from some old tired goals outside sporting activities are non existant. Surely a grant for this is available.
- 75. A Tesco or Morrisons more work and easier access to groceries for the elderly and disabled. The Premier is a rip off and the Spar is mostly empty.
- 76. More for retired people during day such as classes languages yoga music lessons etc.



- 77. A reasonably priced restaurant or café would be good, especially if you don't wish to visit a public house.
- 78. Restoration of the Post Office ability to use all services provided by the Post Office, rather than having to go to Sudbury.
- 79. I think the playing fields should be looked after better and amenities improved for all the younger ones not just a skate park. More lighting to discourage anti-social behaviour and no dogs on the field.
- 80. I would like to see a gym, so folk would no longer have to drive down to Sudbury or Haverhill. The emphasis is on people of all ages to keep fit and with the planned developments the customer base would be there (and from Clare and Cavendish too).
- 81. Indian restaurant/take away. Post Officer to be reinstated.
- 82. Larger school. Larger surgery.
- 83. New sports pavilion offering indoor courts i.e. volleyball, badminton, netball, changing rooms, function rooms, film night, coffee bar. Give village something to take pride in. Outdoor tennis court.







## The school is a vital part of village life



## The Scouting groups e.g. Rainbow and Cubs are an important part of village life








## How much do you agree with the following?

#### G 3 The Parish Council ideally should have more powers over planning decisions



## **G 4** Babergh District Council takes local opinion into account when making planning decisions



## G 5 The younger generation should be more involved in village decision making



#### The following free text responses were received in relation to section G:

#### 122 responses were received in total:

- 1. When visitors attend Parish meetings they are generally ignored, silent until asked to speak. A better and more receptive inclusive method would be to initiate meetings with subject introductions and visitor issues raised at start of events.
- 2. Working residents are unable to contribute where meetings/surgeries are conducted during weekday mornings or afternoons.
- Local council issues should be more widely communicated i.e. through the 'contact'
  magazine / newsletter. The conservation area of Skates Hill / Egremont Street should be
  strictly enforced for planning, satellite dishes, parking, bins etc.
- 4. People could get more involved if people could use the internet to contribute to local issues and mow school field more often. The kids cannot play sports often.
- 5. Not sure if younger generation means teenagers or 50 year olds.
- 6. Before any housing development is done, more village infrastructure is needed to support6y current village let alone the new people coming to the village. i.e. Where will the children of the new housing go? How will the GP practice accommodate the new families? When something is broken getting it fixed asap! Crownfield play area has been out of action for 6 7 months and has not been fixed.
- 7. It's not easy to know much about the village unless you know those involved. A small local paper once per month would be good.
- 8. The younger generation should have a say as most pf the older generations views don't mean anything apparently.
- 9. The various councils need to establish who deals with what and do it.
- 10. The Parish council appears to be more like a private members club rather than a responsible group representing residents as a whole.
- 11. The district council clearly pay no attention to opinions regarding housing with 15 houses being built on land belonging to the church with a covenant to prevent building. Money clearly brought an end to a covenant and unsatisfactory houses have been built to a shoddy standard.
- 12. I do not know enough to score, or comment appropriately.
- 13. As self-builders during the planning process we felt that the parish council turned down our plans for no given reason. We think our home must have been nearby to someone on the committee who didn't want it built. We are grateful that Babergh approved.

The reality is they don't care and I feel punished y the county for having to pay to send my children to their choice of school.
- 25. The Parish is to clicky always have been, fullay people who's been in village 5 min and have not got a clue the parish have no power and make daft descisions and throw money where not needed. Its always been the same.
- 26. Playing field needs more use.
- 27. The Parish Council do their best, but all decisions seem to be made by Babergh or Suffolk County Council who often overturn Parish Council actions. - 50. Developments need to think about the local situation rather than how it helps achieve local housing targets.
- 51. G3 we don't know enough about the power the parish council have at planning stage to answer this question.
- 52. When I have needed Babergh District Council on fly tipping issues, they have not been interested.
- 53. Do Babergh DC take any notice of Parish councils? My opinion is they do not.
- 54. I left the top blank because although they all (councils) try, the government does not listen to us out in the country.
- People know how to contact parish council if they need too, everyone seems to know everyone, this is a nice part of living here. I love this village. Also someone from the council does need to come to 'sensory fun' as they obviously have no idea what it provides for the community there. Perhaps the children centre group would have been mentioned in the section at the beginning of the survey.
- 56. G3 Would prefer to a completely independent body for important planning decisions: knowing people/persons who are submitting planning proposals and being antagonistic towards these [people rather than their proposal. G4 I should like to think so.
- 57. Babergh DC are totally remote from this village. They just see it as 'the go to place' to put development having no idea how they ruin village communities they've dumped on Glemsford for the last 50 years.
- 58. Other than the Babergh council giving back handers the building developers, I strongly agree that our Parish council should have more say!!!
- 59. I have no idea what the Parish council are up to, where/when meetings are etc etc... How do they communicate this?!
- 60. I am 28 and hoping to buy a new home in the village this development could be ideal if planned correctly.
- 61. We do need younger and more open minded people in Parish council to balance decisions fairly.



- 62. G5 Laudable ambition, but probably unachievable. G6 Ongoing issues, needs constant readdressing. Perhaps use annual insert into free newspaper with info and to encourage use of emails etc.
- 63. Parish council should be more involved in running community events not leave it to clubs/societies/church. Should be village fete (not just church). More use should be made of electronic networks (GDPR permitting) communications.
- 64. If further development is carried out it needs to be that the facilities at present don't suffer.
- 65. Don't know anything about the Parish council.
- 66. What is happening with the proposed housing sites? We were asked to submit feedback but haven't heard whether permission has been granted/declined.
- 67. Be nice to be informed of when and where Parish council meetings are to be held.
- 68. I have lived here for six years and still know little about what the village has to offer (events, clubs etc) therefore, a small village newsletter would be ideal.
- 69. If local decision making was devolved to the Parish council there must be a fair, open and unbiased system put in place eg local voting on major decisions such as land development.
- 70. Unless I look online, I don't know what's going on in the village.
- 71. Village information from the Parish council can be found on the computer if interested.
- 72. Babergh & Suffolk councils do not care! Hence state of local roads.
- 73. Glemsford should be kept as a village and not expanded into a town.
- 74. If the Parish Council have more power, as long as they listen to people's views.
- 75. BDC are a complete waste of resources. They are more concerned with their own bureaucracy than meeting the needs of the district.
- 76. Parish councils planning decisions are very random. They seem to do deals with English heritage / environmental and side with each other when it suits them.
- 77. The younger generation have fantastic ideas and it could help give them a purpose in the village
- 78. We never get a newsletter from the Parish Council to keep us up to date on current events. Why not email to those who 'opt in' for this facility if there is an issue with cost of paper or time to deliver......?
- 79. We have a free newspaper delivered I would welcome some idea of progress on local issues at least quarterly from the parish council. The sheet could have a slip for residents to give views to the parish council these could be posted in a box outside the village hall.



- 80. Meeting times are not always suitable for those who work and are not representative of the community age groups.
- 81. BDC looks to revenue from planning only
- 82. Perhaps younger people can be encouraged to join the parish council?
- 83. We have only been in the village for 6 months so difficult to comment here.
- 84. Everyone should be involved
- 85. Glemsford has been damaged enough thanks to BDC. So too Long Melford & Sudbury
- 86. Parish council communication has improved recently.
- 87. Local and parish council may disagree with planning, people/residents council. But BDC will still put an application through even after concerns of local residents. Parish, how is this a fair system? When local people who live in the area are not listened too. Buck is parish council. Instead someone behind a desk who has no knowledge on a village they know nothing about, I feel the council let us down.
- 88. Parish should look at recruiting different ages, race more diversity needed.
- 89. Glemsford is the furthest parish from BDC, it is given little attention and is convenient dumping ground for additional housing and appears to be least important in every aspect. As a very large village it is time for locals to say no in the same way Lavenham does. Glemsford has more linkage to St Edmundsbury than Babergh and should look to move if Babergh merges.
- 90. Bells Lane def needs resurfacing. Lived here all my life, would be nice to drive through main road without all those parked cars.
- 91. Parking in the village is getting worse, have contacted council but to no avail, perhaps they should visit Glemsford in the evening when everyone is home, then they will see how bad it really is!
- 92. Who do you class as the younger generation?
- 93. I have no opinion on this.
- 94. When are the council going to repair the roads surfaces around Glemsford? There is government funding for this. The surfaces near the spar shop are bad and there are areas where water accumulates regularly in the area. The area of Tye Green could be made more attractive on the actual.
- 95. All parish councillors need make declarations of any pecuniary interests or relationships where they allowed to influence decisions/outcomes of village affairs
- 96. I've not had any communication from the parish yet



- 97. I have personally found the parish council very helpful. Not sure however of their full remit. Perhaps some PR would be good. Perhaps a meet and greet.
- 98. A Parish Council website would be useful.
- 99. The changing facilities for the playing field need finishing
- 100. There are enough properties in Glemsford it is supposed to be a village not becoming a town. There has been a lot of development in this village over a number of years. Instead of making road wider would it not be better to resurface the ones we have.
- 101. The younger residents need to be encouraged to have opinions as they are likely to be the ones to stay or go from the village depending on decisions made.
- 102. Decisions on Glemsford should be made by people from Glemsford.
- 103. The parish council appear to be self-serving.
- 104. More bin facilities. More dog bins. More lighting down back alley ways. Lunch clubs with families with disabled people. Youth club evening for all ages. Involve different evening activities for older people over 18 years. Speed signs needed on main road from bottom of school field road, dangerous drivers don't think!!
- 105. I like the surveys as I work full time and am not around to visit meetings. It makes me feel like I am involved with the process.
- 106. As Glemsford grows it's imperative that the infrastructure and facilities grow to meet demand. The playing field has been left as a dog walking field. I would like to see this field benefit all ages. We must involve younger people as they will feel included, less likely to vandalise. Glemsford has the potential to become a village to be proud of. We have to modernise our views and outlook not talk about what has happened in the past but look forward to our current and next generations.
- 107. Both BDC and SCC should take more notice of local wishes and not keep to party dogma.
- 108. The surgery in general appears to put more emphasis on the needs of the elderly or the young. What about the needs of the middle age group?
- 109. It feels as though we could have better access to information and decisions made.
- 110. G3 We are aware they are not skilled in planning. G5 But they can't be forced
- 111. The present Parish Council works hard for the village but it is often ignored by the District who seem to have political agendas at their heart. SCC seem only interested in saving money and a lot of their decisions save nothing and don't consider the people it affects.
- 112. Michael Brown and his team are doing the very best.
- 113. G6 This goes back to the village having a P.R.O. to get ideas across from both sides. The councillors should get among the people more. You never see them in the village. Most people say 'who are they'.



- 114. Maybe worth setting up a Parish Youth Group.
- 115. I find the present set up with the councils confusing when I had in the past try to complain about something I am told it's not their business and pass the buck. I was told that it was some other council's responsibility, it all seems a mess. The council should inform the people more about what is going on.
- 116. Unsure about meaning of 'younger generation' as in G5.
- 117. New residents, especially in new houses a welcome pack with information about the parish council and pointers to other services. Glemsford villagers Facebook page. One off flyer to all with parish council website and welcome but folk need to be proactive too.

#### 118. Unreadable

- 119. You have to live somewhere to know and understand the local issues, not just look at plans on paper or screen!!
- 120. The Parish Council should do something about parking beyond the cherry tree around the bend. Traffic has to go on wrong side of the road to pass parked cars.
- 121. The Parish Council should have more power over planning decisions than BDC have, as they are the people that live here!
- 122. I do feel that SCC and BDC taking little notice of local opinion of planning decisions.



# H 1 Keeping the surrounding countryside green, free from development



# H 2 Keeping footpaths and bridleways open



# H 3 Hedgerows and woods



# H 4 Viewpoints e.g. from the church



# **H 5** Keeping allotments



#### The following free text responses were received in relation to section H:

## 161 responses were received in total:

- As a regular walker, no dog's footpaths and bridleways are essential for all ages. Appreciation
  of wildlife, freedom to build dens, see horses, find treasures in keep healthy in MIND and
  body.
- 2. If there is a waiting list for allotments we obviously need more.
- 3. I feel that the village with the facilities it currently has would be unable to accommodate any further development. The access roads are especially a cause for concern.
- 4. The future stability and health of our village and the society it supports is and will be based on the respect shown by the various councils and civic bodies for our community and environment. If our social laws and rules are not policed they will be stretched and ignored, filtering down through society to the most basic responsibilities we owe to one another. such a decline has begun dog fouling, parking and littering is the pointy end of a wedge that can splinter a society which has great history of community and cohesion. The light and shade of Glemsford is what makes our village such a great place to live.
- 5. Farmers have recently being felling mature trees (e.g. below the church). That there is no control is a scandal!
- 6. Glemsford has a great community spirit. Lets keep that.
- 7. Glemsford is supposed to be a village. The amount of proposed development will kill our rural feel, no further residential building here. Thank You.
- 8. The footpaths and bridleways are an essential part of Glemsford and must be maintained.
- 9. Too many new homes being built Doctors and school won't be able to cope. Village has expanded so much, might be in danger of not feeling like a village anymore.
- 10. The character of Glemsford gives it its charm. Lets hold on to the village feeling even as it grows.
- 11. Having stated that developments in Glemsford is inevitable, 'free from development' is a pipe dream as there is bound to be some expansion of the village envelope the question is where.
- 12. It's a village. Let's remember that.
- 13. New housing is always needed and as long as it's controlled its better than putting it off until it has to be done and there may only be one spot available at that point.
- 14. Encourage inbreeding as this will keep the village feel to Glemsford. It is always handy to have some village idiots from inbreeding.



- 15. The massive lack of maintenance to pathways and green areas is a massive issue. My son recently fell in stingy nettles on the path to the park in Kings Road which was almost blocked with weeds yet we see council tax going up!! The green areas all around the village are not kept on top of at all (2/3 cuts a year) they should be done monthly at an absolute minimum through the summer months.
- 16. There are a lot of surrounding fields/areas currently free from development. I think its important to improve the village we have with the space rather than just increase the population with houses. I believe more facilities should take priority.
- 17. The village is fast becoming a small town and is being overdeveloped. We need to keep a village feel free from development, the infrastructure is not sufficient school, doctors etc. Even the sewerage is not capable of the waste that will be produced by more houses.
- 18. Need to provide housing for the next generation or they will be forced to move out of the village.
- 19. Trees keep being cut down by the farmers (big ones) view from (down to Stansted)
  Glemsford church, massive believe popular tress (30 metres high) this changes the view surely freewill without consultation is not right.
- 20. Too many outsiders.
- 21. We should be kept in the 'loop' with regards to developments in the village rather than relying on rumours and hearsay. A newsletter for example.
- 22. If I wanted a busy town feel I would have moved to one! Keep Glemsford a village please.
- 23. If the village keeps getting bigger, purely on a housing front the impact on the environment will be extremely negative. We already have roads struggling to cope. The village is full of parked cars and adding more to this will be horrendous, as well as a posing further risks to safety.
- 24. Up keep of and maintenance of rivers Glem and Stour.
- 25. The environment and surroundings are very important.
- 26. A Glemsford newsletter to keep all informed of future developments and events within the village rather than speculation would be great.
- 27. Again having just moved answers based on last few months. But have known people I went to school with and friends I have kept in touch with in the area; have always had a connection with Glemsford.
- 28. Development is inevitable but I think to try and preserve what we can of footpaths, hedgerows is important. Having lived here all my life I've never felt Glemsford is held in high regard for its village feel anyway, if its held in high regard by anyone at all. It's in the shadow of places like Cavendish even though they are less well served in terms of doctors/ shops etc and I don't think that will ever change.



- 29. This is a village, not a town.
- 30. In my day we had gala day which we all had floats it was great fun the village pulled together but now no one give's a shit the good old days are gone
- 31. If we are to keep the footpaths and hedgerows there needs to be more funding to keep them and grassy areas maintained i.e. the footpath on the side of the Church hill as its completely covered with overgrowth and the road is used instead.
- 32. Glemsford is situated in a very beautiful part of the country and I believe we should do our utmost to keep that element as it adds to the quality of our lives. Growth is inevitable but it should be produced by the development of small well designed housing projects which enhance the village.
- 33. Its 2018 stop trying to stay in the 1800's
- 34. We need few council bungalows for elderly and disabled people, not private ones.
- 35. The current proposal to change New Street Farm into a wedding venue is a point in question. The area is a special place for walkers and family exercise and to enjoy the countryside and views in relative safety so very important that local views are taken very seriously about refusing this application.
- 36. More attention should be given to protecting the environment from the continuing problems of littering and dog fouling possibly a short police presence with penalties enforced!
- 37. I look at surrounding villages and realise what an amazing community we have, and how lucky we are to have the facilities and clubs etc. There are areas that are needing attention but overall we are very privileged.
- 38. Developments are not 'inevitable', especially as, like with the many other villages in the region, the only effects current villagers will see are the road closures to help in the construction, extra volume of traffic and pollution, pressure on current resources and erosion of a community feel.
- 39. Because surely all of the above aspects are exactly why we all enjoy living here in the first place!
- 40. Our environment is key to keeping Glemsford as a village offering views, walks and spaces to grow produce.
- 41. Glemsford's best feature is the surrounding countryside. Take that away and Glemsford will just be a huge housing estate.
- 42. I would like to see hedges cut from back roads more often (Cavendish Lane)
- 43. Footpath between Kings Road and Harpurs Road. I've lived here for 25 years and I cant remember the last time it was swept. In the summer months it is almost impossible especially for a wheelchair or pram/buggy.



- 44. Yes we want village life. But young people who are Glemsford born and bred shouldn't be casualties as a result.
- 45. Encouraging farmers to comply with putting footpaths back when they have ploughed the fields and removed them.
- 46. Already many parts of Glemsford feel like town suburbs housing estates, but some areas are lovely important to keep the character of a village while maintaining development needs.
- 47. More people from outside will only make life more difficult for us that have been in Glemsford most or all of their life's.
- 48. I am very concerned that more development will cause a loss of social cohesion and community spirit.
- 49. Glemsford is a lovely place to live, parts of this is the easy access to the surrounding countryside. However, people need places to live, those that have grown up here should be able to purchase / rent a home here. In order for that to happen new homes need to be built.
- 50. Enforcement of regulations e.g. conservation area, village envelope, design guides etc. Too much disregard for the above at present.
- 51. Speeding signs more done on speeding drivers. Hobbs Lane should be 30 all the way down to main Rd. Skates Hill though village most are doing 40+.
- 52. H2 Some of the footpaths get over grown and its hard with a pushchair to get through. H3 Private hedges growing too wide and covering footpaths mainly on the Kings Rd loop.
- 53. Any new builds be wildlife and environmentally friendly i.e. intergrade bat and swift boxes and more so wildlife rusts or housing
- 54. Glemsford is losing its charm.
- 55. No more development
- 56. I came to this village 8 years ago and I enjoy being here especially as my bungalow is at end of our village and countryside surround us. But unfortunately the village is becoming a small town with all the building that is going on and the people that are moving in are not going to see the real village life which is a great shame.
- 1. An elevated pathway desperately need for Skates hill, very dangerous for pedestrians. 2. Hobbs Lane and Flax Lane to be widened.
- 57. Glemsford is a very pretty village, lets try and keep it that way.
- 58. All these are very very important to our village way of life.
- 59. So long as the surrounding area is green, and the village has sufficient green areas and open space between buildings and streets, I don't mind greater expansion so long as it is done sustainably, sensibly and properly.



- 60. WE could have a village community garden, plant more trees. Farmers should limit their use of bird scarers
- 61. Would be helped greatly by local farmers keeping footpaths clear and accessible
- 62. H1 Feel build is needed on a small scale but this should be shared between Suffolk villages and not major estates in just one area.
- 63. It's a village, keep it that way. If people want shops and a larger community they can get property in a town.
- 64. A club with good interesting facilities for teenagers village hall for badminton or squash.
- 65. We live in a wonderful part of the country. It views are spectacular and I would not like to see it destroyed by high rise/dense development. More work units should be included in any development. A hub of craft units with café could be developed a nominal rent should be applied to these units to keep people working in the village. We have lost the horsehair factory, Downes, silk mill, Suffolk studio glass, Sudbury snacks, auto stores, bakers, wool shop to name but some. Plus 3 public houses. All these provide work for people of the village.
- 66. Slowly, this is being destroyed. Who is looking holistically at the number of developments around the village and the impact on infrastructure?
- 67. Residents generally value the fact that we live in a beautiful part of the country and there should be no moves to spoil this such as over development. I feel Glemsford has 'done its bit' for housing and maybe its time to look elsewhere, Cavendish maybe?
- 68. Agree with brown fields housing as a priority but need to ensure that adequate parking is available OFF the main access roads in to village. Any green field development should be a planned development that 'adds' to village, its amenities, access to village (e.g. road working, extra footpaths etc) rather than a small group of executive homes giving nothing back.
- 69. Hobbs Lane approach to the village is a litter strewn mess. With permanent orange barriers and pot holes in cannot fill anyone with a sense of pride about calling Glemsford home. I believe it gives the wrong impression to any future homebuilder of small business opportunity.
- 70. First word in response is unreadable. The remainder was: Any development and avoid the village becoming a dormitory and commuter village.
- 71. We live in a village, not a town. Soon, if it is not stopped, all villages will be towns.
- 72. I don't want the village to get big. Its big enough and the bus service really needs a re-think mini bus rather than huge buses.
- 73. General observation Alas! Due to many factors increasing longevity and more family break ups, immigration etc I fancy that Sudbury, Long Melford Glemsford will eventually be fused into one large township inevitable in the long run.



- 74. Glemsford has sustained sufficient development over the years and any more would put all the above at risk. We think our church should be lite at night also what happened to the St George's flag?
- 75. I choose to live in the countryside so I want to stay in the countryside without no more development, If I wanted to live in a city or town I would!! Glemsford should remain a village and not a massive housing development (No to more housing)
- 76. There needs to be better communication and promotion of activities for all ages within our village. We have lived here for five years and not sure what activities there are at the village hall. Perhaps a monthly pamphlet which people can buy they do this in Lavenham and other villages.
- 77. There is no village feel. Would like one. Give lower income families an allotment.
- 78. There is a balance here there is an abundance of green space. It's perfectly possible to develop Glemsford and maintain this. We'd have to build a small town to ruin it!
- 79. I am very concerned how some farmers are able to cut trees down, rip up hedgerows and destroy wildlife habitats without any consultation around the village. Also, there is a real issue with farmers spraying poisonous chemicals onto the land around the village especially 'round up' which has been proved to be carcinogenic. There is a general pattern of people (friends, family, people in the village) complaining of nausea, stomach upsets and headaches around the main spraying times (mainly spring, early summer). I really feel strongly that people need protection from these chemicals being poured on the land unrestricted.
- 80. Keep the 'Horseshoe' as a village facility, a 'quiet lane'. Do not develop Lower Road.
- 81. WE are a rural village and we wish that to remain!
- 82. The village doesn't not need to be free from development but if there are no bus services and the doctors surgery are full this would not be a good thing.
- 83. All of the above are vital to the village
- 84. My husband and I moved to Glemsford nearly 20 years ago and what we loved about it was it's friendly village feel. I feel this, together with our beautiful local countryside is gradually being eroded. I also personally feel that many newcomers into the village have no interest in preserving this or helping in running our clubs and facilities etc.
- 85. I think with Glemsford being a village surrounded as it is currently by countryside the aim should be to keep it as so. Further development would impact the village's countryside and I do not think services offered would cope.
- 86. Housing is important for the growth of the village, but there also needs to be a bigger and better amenities like school and doctors to cope with the increase of people living in the village.
- 87. This is difficult, people need homes to live, they have to be built somewhere, however this could be done in stages other villages have to accept they must be included. I also value and



- appreciate the countryside. If we accept homes are too be built the infrastructure must come with it e.g. wider roads, ample parking, increase in GP facilities, schools and even a petrol station. There could also be a realistic cap on the size of the village/
- 88. Pages of questions. No mention of pensioners, old people, single living alone, empty lives, nobody cares about the old here, bus services further cuts, no way to Sudbury, no late buses or early ones! Many are trapped in their houses. Plus is! No real crime, good place to live anyway.
- 89. Although we have only lived here for 3 weeks we can see Glemsford is already built up to the max. Lets keep the green bits Green!
- 90. Glemsford is an old picturesque village and therefore green spaces, footpaths etc should be preserved.
- 91. Redevelopment of pre existing buildings and extensions to houses should be the only development allowed. To allow farmers fields to be sold for property development is unnecessary and would take away our village feel and destroy our village.
- 92. Keeping the look of new builds to blend in with the surrounding area in style, size and not being too built up with grass area and play areas, fields etc still there.
- 93. The villagers input into these decisions are paramount and therefore this survey which will lead to the neighbourhood plan is a real and positive step forward.
- 94. It would be lovely if Glemsford could go back to being a village where it was a friendly place, but I think those days are gone sadly.
- 95. Avoiding unnecessary and unwanted development is key to maintaining the local environment.
- 96. Taking arable land to develop is wrong. Brownfield sites.
- 97. Large trees have been cut down in the past week in view of the church. Did they have permission?
- 98. At present in danger of becoming too big for a village.
- 99. H1 No one wants the view spoil but people want 'need housing. Everyone complains they can't buy property so it needs building. The planned development in Glemsford was always going to happen.
- 100. It is important to retain the character of the village. Keep the greens well maintained. Retain the countryside but allow small developments for young people.
- 101. Glemsford is absolutely beautiful and one of the reasons we moved here.
- 102. The village is already to big and unable to cope with local facilities and number of cars! The streets are lined with cars making some areas a dangerous



- 103. Farmers and landowners to keep all boundaries tidy but in accordance with good practice eg not vandalising hedges too soon for wildlife.
- 104. All of these are very important to me and feel threatened.
- 105. Glemsford has the best views of any of the villages around here, and they should be preserved for future generations to enjoy the countryside as we do.
- 106. One of the remaining pubs is situated in an ideal location for a coffee where parents can meet up after school drop off etc sadly this pub currently does not even open at lunch for food on weekdays. It has a garden, parking and is under used. Pensioners could meet up too what a waste.
- 107. I feel that the manufacturers of baby nappies and baby wipes would make al of these products bio degradable, and affordable for everyone.
- 108. No central hub to the village as such
- 109. H1 What sort of development? Houses/factories
- 110. We need to make sure that no further large housing developments are sanctioned, in order to preserve the above, and to maintain traffic flow through the village, which is already at bursting point.
- 111. We are situated on the edge of the village with no path to walk safely to the village. There is no village feel extended to residents on the outer edges.
- 112. The village services can only just cope now with demand. More development would cause problems education, health, parking, volume of traffic.
- 113. We chose this village for its countryside, please preserve it.
- 114. refer to previous page
- 115. This topic needs to be carefully balanced with other suggestions such as the widening of roads/ parking restrictions / speed controls. One can very easily contradict the other.
- 116. Please do not develop Glemsford anymore, everyone we meet feels the same.. We love the village and how diverse we are, we have had enough housing, we need more resources.
- 117. As a resident of The Horseshoe I feel I am not a resident of Glemsford.
- 118. All view are important. It seems odd to single out one of the few unoccupied buildings as potentially important to have a view. Views from where people live are important.
- 119. Glemsford does not need to have more houses built. The village is quite big enough, any bigger and the village could not cope.
- 120. Development is often seen as inevitable but if this is the case it should be green as possible. Things to consider are hedgehog highways, education on effect of domestic pets on wildlife, fines for dog fouling etc.



- 121. I think it is very important for the village to remain rural, peaceful and to have a village feel about it. Therefore I strongly agree that this area should remain free from development.
- 122. We settled in Glemsford because of the surrounding environment and the fact it's a village.
- 123. Keeping the open fields and countryside environment, village life is the main attraction of the village area. More housing and/or business development should be discouraged and resisted, otherwise the country life will become eroded and disappear.
- 124. There is little to bond people with village life when they are generally working outside of the locality.
- 125. Development should be a proportion but not too invasive or over bearing on the village community or infrastructure. It is important to keep Glemsford as a village and to maintain the rural setting.
- 126. Have always loved village life and this was one of the key points that drew us to Glemsford.
- 127. The viewpoint from the church is extremely historical. I read a book from the library about the history of Glemsford and there had been a tower where the church is now for hundreds of years. It was a viewing point for invaders crossing the river. Glemsford is a very early settlement.
- 128. Some footpaths are not kept clear enough especially if you have a pram or young child on a hike
- 129. I support the development by the church. But with the cuts to SCC I cannot see that money will be available for road improvement. Will the developers be required to pay for these? The should.
- 130. H1 Having green spaces is important but this should not preclude some housing development. People have to live somewhere and those born and bred in Glemsford or the area may want to buy/have affordable housing/downsize
- 131. There is a huge puddle near the church when it rains needs to be drained it is a terrible flood.
- 132. The surroundings of the village are important for free exercise opportunities and walking where we live. The countryside is an important educational tool for children.
- 133. Over housing means Glemsford is becoming a small town.
- 134. Any extensions to village i.e. new housing has to be sympathetic to the village and be mindful of current village limitations e.g. road access, road width, school size, GP size.
- 135. More activities for the younger / teenagers.
- 136. People outside Glemsford say it is a mini town. It is losing its village status.



- 137. Rubbish chucked on floor. Parks being vandalised school field park. Main post office at Broad way stores is out of action. More lights back alley and past Glemsford school at the bottom of road as we only have one light. Need lighting on school field park as the older people go into the park and disturb the people living there. Loud music being played late at night. Speed signs on main road from bottom of school field people drive to fast. More street lights needed in some places of Glemsford.
- 138. The countryside and allotments encourage people to walk and get out of the house they are what made us decide to move here.
- 139. I have seen this village grow as I been here from a small child I think the village has grown too big.
- 140. I feel I have not lived here long enough to add much here but I do feel footpaths and bridleways etc are important for dog walkers and riders to do that safely.
- 141. There appears to be an opinion that Glemsford is of less importance in comparison to neighbouring villages. Other areas already have speed controls and the power to limit over development.
- 142. All these issues are vital in keeping Glemsford as a village. It is part of why some of us chose to live here.
- 143. Do not spoil our wonderful views.
- 144. More pride in the village by creating a history of village display also a duck pond.
- 145. More care and attention to our river banks. The Environment Agency have been cut back so much they are unable to maintain basics.
- 146. We have an ideal place for a new development at the top of Park Lane next to the existing estate. Which would save the village from spurious development.
- 147. Despite the need to provide additional housing it is important to maintain clear boundaries between developed areas and countryside controlling sprawl. Should have high importance. Reinstating the railway between Glemsford and Sudbury should be an aspiration.
- 148. Whilst I agree we don't want too much development we should remember that people need places to live in otherwise young people will have to move out of the village they were born in so some development is needed.
- 149. Fly tipping, rubbish from cars and vans. Hobbs Lane is a problem.
- 150. I am strongly opposed to mass development in the village.
- 151. The general condition of the village seems to be deteriating. Street cleaning, grass cutting appear to be carried out sparingly. Perhaps a local community initiative to clean up the centre of Glemsford would be welcome.



- 152. Everywhere is under threat from urbanisation. Village life is very important. We will need fields for growing food more and more. Wild life must also have more protection. It is extremely important. I feel very strongly about this.
- 153. Surroundings of Glemsford are beautiful; scenery spectacular. It would be a pity to spoil any of this fine walking countryside. It must maintained.
- 154. No mention of wildlife and local ecology, this should be taken into account. We have foxes, hedgehogs, deer, grass snakes, newts and many bird species in and around the village, we need to take this into account in all development.
- 155. One accepts that development will happen and as such it is inevitable that it will be on the edge of the village and therefore the surrounding countryside. Consequently the consideration should be that it must be the most appropriate place for the village with regards to access to amenities.
- 156. If there is going to be development (and as the neighbourhood plan is not a 'no' option) then it has to be done in the most appropriate site with great consideration given by the green and open spaces within it.

- 160. Glemsford is a lovely village. Do not over develop it.









- 1. Discrete bin stowage, hidden TV comms aerials. Access high enough for larger (higher) removal vehicles, not like the low access to new development opposite the Cock, which exacerbates traffic issues.
- 2. Improved approach roads and pavements with landscaping, open spaces and hedgerows.

- 320. Most of us live in a village because the seek village life why would we want to change that?




