

Care Market Strategy

On Tuesday 13 May, Cabinet approved the council's new five-year Care Market Strategy, which replaces the previous strategy from 2021-2024. The strategy sets out how the council will work with care providers in the county and other voluntary and community organizations to ensure there is enough care accommodation and workforce to meet adult social care need.

The council has a legal duty to do this and care purchasing is one of the largest costs faced by the council – over £380m in the 2024-25 financial year, with demand forecast to keep growing.

The strategy was developed in partnership with care providers, NHS Integrated Care Boards and Healthwatch Suffolk, with a focus on supporting people with higher additional needs such as dementia, neurological illness and autism, promoting independence where possible and providing better support for unpaid carers.

Council Objections to Nationally Significant Infrastructure Projects

The Cabinet meeting on 13 May also agreed that the council should object to the proposals for the Sea Link Grid Reinforcement, which is a Nationally Significant Infrastructure Project (NSIP) creating an undersea link between Kent and Suffolk, making landfall near Thorpeness and including a converter station being built at Saxmundham.

The council acknowledged that the infrastructure was important for connecting low carbon energy developments, but that they had concerns about a number of issues, including the proposed bridge across the River Fromus which was felt would had significant adverse effects on the local landscape and character, and the inclusion of 7am to 5pm on Sundays and Bank Holiday Mondays in the working hours, as this would not give local residents any respite from the construction works.

The council also reiterated the lack of coordination with other energy projects in the county, particularly National Grid Ventures' Lion Link project which is due to make landfall further up the coast at Walberswick.

The council has also objected to the plans for Eco Power's new large solar farm in north Suffolk, based on several factors including the loss of good quality agricultural land, the impact on communities and the local landscape and damage from cable corridors. A statutory consultation on the plans is expected later in the year.

Council Annual General Meeting

On Thursday 22 May, all three motions tabled were passed by the council, these included a motion against the government's proposed changes to public consultation for Nationally Significant Infrastructure Projects (NSIPs) like Sizewell C, Sea Link and Lion Link and solar farm applications.

The council also agreed motions proposing a ban on live animals being used as prizes on council land, and to support the campaign for Police Community Support Officers (PCSOs) to be eligible for the 20 year long service medal which is currently for warranted police officers only.

The meeting was the council's AGM (Annual General Meeting), and a new Chair, Cllr Jessica Fleming, and new Vice Chair, David Roach, were sworn in during the meeting.

Local Government Reorganization – Engagement Meetings

Suffolk County Council is currently arranging meetings with town and parish councils to engage with them about the coming changes in local government which will see Suffolk's two-tier system (districts/boroughs and county council) move to unitary councils/mayoral model which will undertake all services.

As the administration's position is that one council would be best for Suffolk, it is likely that they will be promoting this at the meetings. County councillors have not been invited to the meetings but as your representatives, we would very much like to be there – if you are attending one of these meetings, please make contact with your local county councillor to find out if they are coming.

The meetings are being organized by the council's communications team and will be around the county in the next couple of months.

Consultation launched on Developer Contributions

Suffolk County Council has launched a consultation so Suffolk residents can give their views on the contributions which can be sought from developers proposing major planning applications.

In 2011, the council published the "Developers Guide to Infrastructure Contributions to make developers aware of what they should consider, and the financial contributions they should take into account to mitigate for the impact of new developments such as housing estates.

The guide has been updated periodically since it was launched, and has now been reviewed and is out for consultation focusing on early years childcare settings, education costs, libraries, and waste infrastructure contributions. Developers need to provide funding to the county council to absorb the impact of extra housing to enable it to provide council services, and the consultation asks for public feedback on how this should be calculated.

Suffolk Archives wins major Museums & Heritage Award

Suffolk Archives is celebrating after scooping the Community Engagement Programme of the Year title for its Arrivals: Celebrating Migration to Suffolk project at the prestigious Museums + Heritage Awards last night.

The judges said: "Comprehensive, thoughtful and effective, this winning engagement programme successfully reached beyond its organisation's traditional audience, achieving impressive results with a strong legacy." Co-curated with diverse local community groups, it explored historical and contemporary migration experiences to Suffolk since the end of the Second World War.

Engagement programmes included art installation The Journey, created with local groups, artists, and schools. The flock of 125 birds, each decorated to represent a unique migration story, is currently on show The Hold in Ipswich – home of Suffolk Archives, which is a Suffolk County Council service.

There was a free exhibition which included items from Suffolk Archives' collections, as well as some on loan from communities across the county that celebrated different foods, clothing, traditions, and culture. There were also oral history recordings, stories of migrant entrepreneurs, and archive materials from the Ipswich and Suffolk Council for Racial Equality.

The Museums + Heritage Awards celebrate the very best in the world of museums, galleries, and cultural and heritage visitor attractions. This year's shortlist included entrants from across the UK and 14 other countries. Arrivals: Celebrating Migration to Suffolk was made possible by The National Lottery Heritage Fund.

Suffolk Archives' current exhibition is Departures, which explores emigration from Suffolk. It runs at The Hold, on Ipswich's Waterfront, until 31 May with a programme of tie-in events. Visit www.suffolkarchives.co.uk for more details.
