01.11 Chairman's announcements

05.11 To adopt minutes of Council meeting on the 13th Oct 2015

It was resolved to adopt the minutes of the meeting held on the 13th Oct 2015.

06.11 Matters arising from minutes of the last meeting

It was resolved to go ahead with the quote of £700 to cut back the hedges on the playing field and around the village hall.

The dead silver birch tree at the village hall has been felled at a cost of £430. It was reported that the remaining silver birch trees are in need of being felled and replaced. A second opinion is required. This is to be looked into and quotes obtained.

The cost of accrediting a dog warden would be in the region of £1000-2000. Enquiries are to be made to see if anyone is interested in the position.

It was resolved to spend a maximum of £400 on steel sides for the youth shelter on the playing field. Cllr Mallalieu will organise this.

DCllr Kemp – a full report can be read on the website. Unfilled potholes are to be chased up for repair. White lining at junctions continues to be an issue. Contractors are very much behind schedule.

DCIIr Holt – No confirmed details of the devolution process. An enquiry has been raised as to whether the broadband mast on the Church needs planning permission. The enforcement officer is looking into this. Also, an enquiry was made about the new windows at The Briars, which is in a conservation area. The enforcement officer is looking into this also. It is hoped the affordable housing development will commence in April.
