An enforcement officer from BDC is to visit Fern Meadow to address concerns about the play park and surrounding area.

The playing field trustees have offered to pay for the electricity supply to be connected to the changing room container (excavations to be completed by the football club)at a cost of £716 plus VAT. It was hoped the VAT would be reclaimable, but this now seems unlikely.

As Shared Access would require access over Parish Council land it is hoped that any funding received could be used for repairs to the village hall approach road.

15.07 Woodland Trust trees/shrubs - future of

A high value of trees, shrubs, steaks and covers are still being looked after by various people. It was agreed that it would be a good idea to plant a majority of these around the allotment site. Any remaining would be used in the proposed land swap on the playing field or offered to the public.

A letter had been received from the scouts asking about ideas for the siting of a container for storage purposes. It was explained that the scouts are happy to consider any suggestions, possibly a purpose built shed or even a shared facility. Fund raising will be done if necessary.
