Further concerns were raised concerning the possible closure of Woodlands Children's Centre, a much need facility which was only built 4yrs ago at a cost of approx. £700,000.

**DCIIr Thake** – Planning protocol is to be decided. The application for development of the Downs site is to go before committee next week. There are no further developments concerning the Silk Mill site.

### 11.09 Woodlands Centre - Gordon Jones, Cabinet member for children's services

Gordon Jones together with two representatives from Suffolk County Council (Allan Cadzow and Anna Shaw) attended the meeting to discuss the future of Woodlands and whether services should be repositioned. It was advised that the building is needed as a nursery/early years facility and that children's services provision will remain, but outside of the building. Lengthy discussions were had highlighting the concerns of the Parish Council. Frank Field (MP) will be visiting Suffolk in the next 6weeks as part of the on-going consultation, which all are encouraged to complete. Funding is to be looked into with reference to the possibility of use of specialist space (i.e. midwifery services). It was confirmed that the consultation process is not about reduction of the staff complement, although a separate review is already underway with a formal consultation with staff expected to take place in the Autumn.

# 12.09 Village Hall Plan - update

*It was resolved* (Cllr Plumb abstained) to use the service of Harcourt Powell to produce initial plans and subsequent services at a cost of approx. £1300 plus VAT.

*It was resolved* (Cllr Plumb abstained) to keep the ladies and gents toilets in their current position and to go ahead with their refurbishment. CCllr Kemp is to be asked if funding is available.

#### 13.09 Craft afternoon - use of hall

It was resolved to allow use of the hall FOC.
