CCIIr Kemp - a full report can be read on the website or at the clerk's office. Glemsford Parish Council Meeting

Alison Wheeler from Suffolk Libraries explained the difficulties that had arisen due to anti-social behaviour at the library. She was saddened that a member of staff was not at work due to issues with young people. A request was made for help from the Parish Council and the Community to help resolve these problems and on ways to look forward by offering more facilities and constructive engagement to the youth of the village . It was agreed that the Wi-Fi would be turned off from 5pm – 9am each day (to be reviewed at a future date) and that clarity from Suffolk Police was being sought on comments made. It was also agreed that a meeting be arranged with the Police (as this is mainly a Police issue) together with Suffolk Libraries and the Parish Council in attendance to avoid the situation of withdrawing library facilities.

12.11 Library - supply of new projector screen - use in village hall

The Arts Council has agreed to provide Glemsford Library with a digital projector. *It was resolved* to install this in the village hall.
